## Purpose

- To consider approving a Resolution
- Awarding a bid in the amount of \$895,626.73
   with 15% for contingency
- Authorizing the City Manager to enter into a contract with Clark Construction of Texas, Inc.
- FY 2024 Street Maintenance Program



- The scope of work for the Year 5 Street Maintenance program consists of milling and providing an asphalt overlay, and 21 ADA ramp modifications.
- Mill & Overlay Streets:
  - Grass Valley
  - Strawflower
  - Peachtree St.
  - Cherryleaf Dr.
  - Twinspur St.
  - Wildfern
  - Pepperwood
  - Sulky Ln.



- The streets were included in the FY 2024 Street Maintenance Program based on the Pavement Condition Index (PCI) Scores
- The sidewalk ramps requiring modifications are being replaced as part of the ADA ramp replacement program
- The project was designed by the Ardurra Group



- A bid package was developed and advertised
- Bid advertisement placed in the Express News on two consecutive Sundays
- Bid documents also placed on the City's web site & public plan rooms
- The bid opening held June 10, 2024, with 2 companies submitting
