

# STATEMENT OF VIOLATION AND REQUEST FOR HEARING

Description of Violation: On October 14, 2024, I observed large piles of tree debris waste stockpiled at the center of respondent's property and a 5ft berm being constructed at the easement along the front and along the neighboring property line. The tree debris was being hauled in from other offsite properties.
- 6. Date violation first observed: October 14, 2024
- 7. Date Owner/Person in charge received Notice of Violation: On January 8, 2025 a Notice of Violation was sent via USPS certified letter with return receipt requested. Notice was signed for on January 10, 2025.


