ORDINANCE NUMBER 2025-3

AN ORDINANCE OF LEVY COUNTY, FLORIDA, AMENDING THE CODE OF ORDINANCES OF LEVY COUNTY, FLORIDA RELATING TO THE COUNTY DEVELOPMENT DEPARTMENT AND PLANNING AND ZONING DEPARTMENT; BY REPEALING OBSOLETE CODE PROVISIONS; BY AMENDING APPENDIX B "SCHEDULE OF FEES, RATES AND CHARGES"; BY AMENDING SECTION 50-718 TO TRANSFER AUTHORITY FOR PERMITTING TEMPORARY EXCAVATION AND FILL ACTIVITY FROM THE DEVELOPMENT DEPARTMENT TO THE PLANNING AND ZONING DEPARTMENT; PROVIDING FOR INCLUSION IN THE CODE; PROVIDING A SEVERABILITY CLAUSE; PROVIDING A REPEALING CLAUSE; PROVIDING DIRECTIONS TO THE CLERK AND PROVIDING AN EFFECTIVE DATE.

In accordance with Section 286.0105, Florida Statutes, should any person decide to appeal any decision made with respect to any matter considered at this meeting, such person will need a record of the proceedings, and for such purpose, may need to ensure that a verbatim record of the proceeding is made, which record includes the testimony and evidence upon which the appeal is to be based.
