A. Requesting Board approval of Resolution 2020-099; adopting FY21 Tentative Millage.

Mr. Blanton stated this resolution will adopt the tentative millage rate of 9.0000 for the General Fund of the County for fiscal year 2020/2021. This represents a 5.58% increase over the rolled back rate of 8.5247 mills.

Comm. Brooks asked if there were any audience members wishing to speak for or against the tentative millage as presented. There were none.

Comm. Rock Meeks made a motion to approve Resolution 2020-099 as presented. Second was made by Comm. John Meeks and the MOTION CARRIES.

B. Requesting Board approval of Resolution 2020-100; adopting FY21 Tentative Budget.

Mr. Blanton stated this resolution will adopt the budget for fiscal year 20/21 in the amount of \$98,838,044. This tentative budget has not changed since the presentation on August 4<sup>th</sup>.

Comm. Brooks asked if there were any audience members wishing to speak for or against the tentative budget as presented. There were none.

Comm. Joyner made a motion to approve Resolution 2020-100 as presented. Second was made by Comm. John Meeks and the MOTION CARRIES.
