#### COUNTY COORDINATOR

Present proposed amendment to the Levy County BOCC Policy and Procedures #305 PAY PROCEDURES to clarify certain pay increase practices. The addition of proposed language policy is as follows:

The Board's established procedure is to give Department Head's, other salaries employees and positions not listed under LIUNA contract in PERC documents the same wage increase negotiated for LIUNA covered employees. (Exception would be IAFF covered employees).

Comm. John Meeks stated a second advertisement had been placed and they are currently awaiting responses.

Clerk of Court, Danny Shipp spoke to the Board, giving an update regarding the Supreme Court and 8<sup>th</sup> Judicial Circuit's decision to move back into phase 2 for COVID restrictions. This will only affect the Judicial wing of the Courthouse. He stated the Clerk's side of the Courthouse is still open for business as usual with no mask mandates or distancing restrictions.

Sue Beaudette, Town of Bronson spoke to the Board thanking Mr. Dean and Ali for their assistance in planning the Candidate Forum to be held in the Commissioner's meeting room for the municipal candidates on Thursday, September 9<sup>th</sup> at 6:00 P.M. The municipal election will be on Tuesday, September 14<sup>th</sup>. There will be a "Beautify Bronson Day" on Saturday, October 3<sup>rd</sup> beginning at 10:00 at the Town Hall. She stated volunteers are welcome. The Levy County Veteran's Day Parade will be held Thursday, November 11<sup>th</sup> in Bronson this year and will begin at 4:00 P.M. A ceremony will take place at 6:00 P.M. at the park followed by fireworks at 8:00 P.M. Ms. Beaudette then inquired of the status of the old gym and if there had been any conversation regarding the Town's request for its use.

Mr. Dean responded this is being discussed and the building is being brought up to code for use.
