

## Familiarity with EOC Standards, Procedures and Regulations

The Hillsborough County Public Safety Operations Complex (HPSOC) and EOC in Tampa, FL is a good example of that. While designing the HPSOC Dewberry submitted to and coordinated with FDEM (Florida Department of Emergency Management) to verify compliance with the state of Florida requirements. The project also included a helipad that required submittal and approval to the FAA (Federal Aviation Administration). We have provided more detail on this process on page 7 of the HPSOC project page.

#### 911/Dispath Centers

The design of a 911 center should create a balance between occupants of the facility accounting for the stressful nature of their tasks and the protection of these occupants from both natural and human threats. Coordination to create a well-defined workspace molding workstation configurations, ergonomics and technology to create a comfortable working environment so that surroundings are not adding to the stress from important job duties. By working together with all required vendors, the design team prepares the Public Safety Answering Point (PSAP) to address all data, electrical, grounding, cooling, cable management, footprint and storage requirements. The interior space is complemented with natural light, acoustics, air flow modifications to create a proper working environment for 24/7 occupancy. The Alexandria Police Headquarters 991 Call Center, was programmed for the third floor to take advantage of the higher elevation to maintain uninterrupted operability.


## **Experience with Hurricane Hardened Buildings**

#### **Renovation Project Experience**

We understand that the county would like to renovate the current EOC into a new 911 Dispath Center and that the design for both will be concurrent. Due to this, minimizing disruptions to the functionality of a facility is key to successful renovation projects. Our experience has taught us several inexpensive and creative ideas that can greatly ease and minimize disruption. Critical features include:

- Developing a design that is compatible with phased construction.
- Development of a phasing plan that is clear and complete.
- Defining and documenting constraints that would dictate timing of construction activities (noise, smells, utility interruptions, etc.)
- Documentation of temporary partitions and building egress must be clear and correspond to the phasing plans.
- Define a timeline for construction, punch list, and move-in for each phase of the project.
- Maintain constant communication between the Owner, Architect and Contractor.
- Early move management planning and phased move diagrams to coordinate department moves with few surprises.

If the county should decide to phase the renovation, Dewberry is well prepared to assist them in that effort.


An example of a successful phased renovation/addition project is for the Bartlesville, OK Police and Fire Municipal Complex, a 1941 Art Deco station that needed to remain operational during a multi phase construction project. Phase 1 involved a two-story addition for living and bay spaces; Phase 2 involved moving crew over into the new addition and admin staff into temporary quarters; and, Phase 3 involved the renovation of the existing 2nd floor admin / training areas - all while providing uninterrupted emergency service.

Successful phasing projects require constant communication with all parties to stay informed. Even during the pre-bid construction meetings, the design team will work with all bidders to help them best understand the phasing intent. There should be a mutual understanding by all of what the minimum operational conditions and acceptable level of inconvenience are. The design team will need to know how long various staff can be uprooted and what kind of temporary adjacencies are acceptable. Utilities should be maintained as much as possible. Clear construction documents with careful coordination and overlap between phases is critical.

There also needs to be flexibility of the users and those in management to prepare for some potential delays due to unknown conditions always involved in renovation projects. Safety and protection of all the users working so close to construction activity is also paramount. It will be the mission of the project team to be creative in our problem-solving and leverage your resources.

## Hillsborough County Public Safety Operations Center and EOC (HPSOC) TAMPA, FL

This new Public Safety and Training Facility is located on a 19-acre site. The program includes 5 major components: the Incident Command Center, Dispatch Command, Information Technology Services, Fleet Services Repair, and Fire-Rescue Training. Other county functions included in the project are a 311 Call Center, Radio Facility and Warehouse. The Fire Training Facility is specially designed to meet the Florida State Fire College Certification and is a 24/7 facility. Additionally, it is designed to accommodate 276 personnel during incident activation. The building and structure are hardened and designed to be resilient against the coastline hurricanes, withstanding 200 mph storm winds.

The project was developed as a design-build project based on a limited set of criteria documents issued by the County, increasingly challenged by the pressure to deliver the project in a very restricted budget, and a compressed 22-month design and construction schedule. This project required creative and new ideas, in order to simplify the criteria package and yet increase the level of design, in both the enhancement of users experience and the civic presentation of the building to the public.

#### **RESILIENCY PLANNING ESSENTIALS**

Resiliency Planning was integral to the design of the HPSOC and EOC. To achieve resiliency, the building envelope, redundant building systems, and site were designed beyond the typical office building. The building envelope was strengthened, structural requirements increased, and redundant building systems were designed to maintain operations during natural and manmade events. The site was also analyzed and designed to provide proper site access control, define secure and public zones and reduce hazardous windborne debris.

## ENVELOPE SURVIVABILITY – ESSENTIAL FACILITY DESIGN

The HCPSOC building envelope and associated structures were designed to meet the heightened wind speed of 200 mph, three-second gust ultimate strength structural design, and large missile impact required for essential facilities as defined by the Florida Building Code. All exterior walls were designed as tilt-up concrete construction. Aluminum doors, frames and windows were designed/specified with Level E large missile impactresistant insulated laminated glazing, fully tempered with manufacturer's NOA (Notice of Acceptance). A composite roof design was utilized with increased structural members to complete the survivable envelope in conjunction with the exterior walls and openings mentioned above. All canopies were designed with prefinished exposed and galvanized steel to verify all exterior attachments to the building envelope meet the durability of heightened wind speed and longer life.





## MAINTAINING CONTINUOUS SERVICE - REDUNDANT SYSTEMS DESIGN

The HCPSOC is required to provide utility systems backup in the event of prolonged power, water, data, and sewage outages. The facility is designed to be fully functional during a category 5 hurricane, and provide service to the community after a disaster. To achieve this, emergency generators were specified to provide 72hrs of continuous power. As the project includes a Communication Public Safety Answering Point (PSAP) 24hr back up was a minimum requirement. Automatic transfer switches enable a continuous transfer of power to the generators. The generators are fueled by above ground fuel tanks in manufacturer furnished protective enclosures. All HVAC equipment, pumps, etc. at the exterior central energy plant are surrounded by concrete tilt-up panels and an expanded metal mesh with galvanized steel roof structure to provide protection from wind borne debris. An above ground tank provides fresh water for the building. A below-grade sewage storage tank guarantees continuous service during activation in the event of a power outage or a broken line. ## **Alexandria Police Headquarters and EOC** ALEXANDRIA, VA



# TECHNICAL APPROACH



#### **Project Understanding**

We commend Levy County for its efforts in securing funding from the state of Florida to build a new County Public Safety Complex/Emergency Operation Center (EOC) and remodel the existing EOC building into a new 911 Dispatch Center. This achievement is a testament to perseverance and commitment.

Our team recognizes that these two new projects will result in facilities that better serve both **Levy County and the Department of Emergency Management**. Both projects will solve several ongoing challenges and fulfill critical needs for the county, in addition to providing updated space for current and future employees within the department.

Additionally, these facilities will provide the county with:

- Sufficient and adequate space for employees and equipment not only during routine work hours but also during high-wind events.
- A self-sustained Public Safety Complex that will remain operational at full emergency functionality and occupancy for at least 72 hours.
- Meeting the requirements of the Reference Manual to Mitigate Potential Terrorist Attacks Against Buildings (FEMA 426), and Crime Prevention Through Environmental Design (CPTED).
- Current code requirements and best practice standards for Emergency Operation Centers and 911 Dispatch Centers.
- A professional workspace that promotes and enhances health and wellness

Dewberry understands the project will be delivered in two phases: Schematic Design Documents and 90% Construction Drawings and Specifications including wind load and wind-borne debris impact product performance certifications or test reports. Both sets of documents are to be submitted to FDEM for their review and comment. Our services will include a site survey, site master plan, spatial needs assessment, and an opinion of probable cost in addition to structural, mechanical, electrical, and civil documents.

We recognize that Levy County has the potential to be impacted by hurricane related events and the critical aspect of designing resilient facilities in coastal areas. Our expert team of public safety facility designers has recently performed similar projects in Florida and nationally. All documents will be designed based on the ICC/NSSA Standard for the Design and Construction of Storm Shelters (ICC 500-2014) and the 2020 Florida Building Code, 7th Edition. The most stringent aspects of each code will be applied to the design of your facilities.

Dewberry's experience includes numerous completed facility designs and includes multiple award-winning projects. Public safety work a core area of our expertise. We are excited about the opportunity to work with Levy County to make your community safer and more resilient. The design team we have assembled is available to begin work on your project as soon as we commit. The professionals assigned will remain involved from the beginning to the end as needed to maintain the continuity critical to the success of the project.



### **Technical Approach**

This Work Plan provides a detailed look at all critical elements and milestones in the development of the project. Our approach to the design and management of this project begins with the development of a complete understanding of the goals and objectives of our project team. This understanding serves as a basis from which all subsequent decisions regarding the design and management approach are made. While budget, schedule and project scope issues are universally critical to the project's success, the way each is addressed must be "tailored" to the project's unique needs.

#### **Project Kick-Off**

As soon as our team receives the Notice to Proceed, we will hold a kickoff meeting with project stakeholders, County leadership, and our team. This meeting will allow all project staff to meet and gain familiarity. It will provide a formal venue to discuss priorities, major project deadlines, key milestones, and any other project logistics. We will also discuss a comprehensive project schedule with certain immediate milestones and deadlines established so that the team can start at a deliberate pace that will set the tone for the whole project.

#### **Program Validation**

We utilize planning surveys to garner critical information in several categories. The surveys seek to understand the administrative nature of the departments by determining the number of employees, nature of shifts, organizational structure, and unfilled positions and spaces that may be desired.

Once the surveys are received, our team will conduct interviews with all staff of the Emergency Operations Center including but not limited to 911 communications and county personnel. The interviews will focus on questions that arise from the survey responses, and further explore the day-to -day operations and workflow of county personnel.

### **Master Planning and Design Charrettes**

Upon completion of the surveys, Dewberry will create the first draft of the program for review by the Board of County Commissioners and project stakeholders. Our team will review the program with the county and make appropriate revisions, and will then conduct master planning for the Emergency Operations Center and the 911 Dispatch Facility. The master plan will lay out all facilities on the project site.

Dewberry will also lead pre-design design charrettes. Charrettes will entail an all-inclusive design meeting concerning the site and the two determined facilities for the optimum security of the site for staff and community use. Design considerations for the site need to account for public vs. staff spaces, identifying locations for site access, parking, and area needed for stormwater retention.

Once feedback is heard and considered with county staff and project stakeholders, the design team will revise the concept site plan while concurrently working to start the initial concept floor plans for the second design charrette. During the second design charrette, floor plan adjacencies will be developed for both the Emergency Operations Center and the 911 Dispatch facility. The floor plan adjacencies will then be further developed into concept plans.

### **Design Refinement**

For the second design charrette, our team will present the initial designs that arose from the first design charrette meeting. A discussion of the pros and cons of each design will be prepared for review by all stakeholders of the project. We will examine potential design improvements for each scheme developed and weigh the advantages of each.

By the end of the design charrette, we will have a clear consensus of the design aesthetic of the architecture, landscape design and layout, site circulation of both vehicles and pedestrians, site access, facility entrances, division of adjacencies, and staff workflow within each facility.

#### **Exterior Security Zoning Strategies**

Force protection and security measures shall be consistent with the Reference Manual to Mitigate Potential Terrorist Attacks Against Buildings (FEMA 426), Crime Prevention Through Environmental Design (CPTED) or other federal or state recognized best-practices guidelines as approved by FDEM. Our team will utilize target hardening, which often includes such site security design features as perimeter fencing for secured staff parking lots, structured parking, site lighting, parking and drop-off design that supports access and security considerations. We will also include protective landscape design features, which should always be integrated into the overall secure facility design which may include crash rated bollards or planters, grade changes with plinths, and good standoff setbacks.

#### **Final Schematic Deliverable**

Once we have developed a design preferred by all stakeholders of the project, the Dewberry team will refine the drawings of the plans, elevations and renderings. Our team will work closely with our estimators to discuss the design of the site and facility in detail. Once the estimate is completed, our team will review the estimate and provide feedback using other project data from our projects as a comparison to the estimate. If the project is not within budget, our team will bring suggestions for changes to the design to bring the project into budget.

Once the estimate has been reviewed and all design changes have been aligned with the budget, all schematic drawings will be presented to the county at a final schematic design meeting. The final schematic design set will also be provided for review by the Florida Division of Emergency Management.

#### **Cost Control**

Our Design Team has extensive experience to implement the most efficient and cost-effective designs. We achieve this through our coordination with the design team and continuous professional improvement to find better methods and ways of achieving cost effective results for the overall project. Due to the economic variables, we propose hiring an outside cost estimating firm with knowledge of the local market. With the assistance of our consulting cost estimator, CC&A, we can evaluate design decisions. CC&A will provide estimating services during the schematic design phase of the project.

#### 90% Construction Document Phase

With the City's approval and acceptance of the schematic design documents, the design team will move to producing the project's preliminary construction documents. During this phase, the efforts of earlier design activities are refined and incorporated into a final set of documents that give sufficient detail to bid the project for construction. 90% preliminary construction documents will also be provided for review by the Florida Division of Emergency Management and the County in order to make sure the project continues to align with all expectations. In addition to the County's reviews, the design team will internally monitor document quality with formal QA/QC during development and prior to submitting 90% documents to the County and Florida Division of Emergency Management.

The Construction Documents will be signed and sealed by our Florida licensed design professionals.

# **Quality Assurance/ Quality Control Policy**

Dewberry considers quality assurance and quality control to be critical components of our overall design methodology and project management approach. To prevent undesirable or unacceptable design outcomes, Dewberry utilizes a rigorous Quality Management process that establishes a baseline for our projects Quality Assurance and is provided for every project Dewberry produces. This system requires internal reviews of the design documents at every phase and schedule milestone of the design process to discover inaccuracies and facilitate additional coordination.

Along with Dewberry's Quality Management System we conduct internal Design Team meetings to review coordination items, discuss potential cost savings to the design and review the internal production schedule. This method has been successful for Dewberry. We continuously review our processes and improve on our techniques.

Rather than treat quality control as a separate function that is overlaid with a project's development, we practice continuous quality assurance that is embedded into our entire design process and underlies the planning, design, and construction activities.

The focus and intent of Dewberry's continuous Quality Management System is to attain excellence in the services we perform for our clients. Therefore, we will strive to provide the best professional talents and implement best practice solutions on all of our client's projects.

Our process begins with the development of a detailed Project Work Plan and ends with actionable items to improve the process and the quality of our work, within the familiar ISO 9001: 2015 process that utilizes the Edward Deming principles of the "Plan-Do-Check-Act" framework. Our quality processes exceed many of our client's expectations. Our focus is on continuous improvement, which integrates lessons learned and best practices into our everyday design process. We emphasize successful execution with the use of Project Planning at the beginning of every project. The Project Work Plan entails simplifying the process and mapping out the project path with Client goals, budget, schedule, and quality that is scalable and flexible to be tailored to the Levy County's project requirements and user needs.

#### **Bidding Phase**

Once the Preliminary Construction Documents are reviewed and accepted by the County, our design team will assist the County in preparing the formal bid documents. This includes preparing the required technical documents for the bid package and working collaboratively with City Purchasing in the preparation of the front-end documents. Our team will schedule and attend a pre-bid conference for interested parties, review substitution requests, respond to Bid Requests for Information (BRFI's), provide clarification on the design intent, and prepare Addenda as necessary. Our design team will assist the County in evaluating Bids to make sure the scope of the project is properly covered by the apparent low bidders.

# Construction Admin/Construction Management Phase

If desired, traditional construction administration services could be provided for this project as part of basic services. This includes participation in preconstruction and construction progress meetings; conducting periodic site visits; review and approval of contractor schedules, shop drawings and payment request reviews; verification of compliance with the contract for construction; responding to Requests for Information (RFI) and substantial completion and final inspections.

Continuity from design to construction will be seamless for our team as they will be on the entire project from beginning to end. Bi-weekly site visits will be made by the design staff to observe general conformance with the design intent of the construction documents. Dewberry will be the main contact during Construction Administration with assistance from the Project Architect who will lead the effort. The team will address technical issues associated with the project, oversee the construction administration efforts, and be the regular point of contact for both the county and the General Contractor.

#### **Design Cost Control**

Our team's concern for meeting a project's budgetary requirements is reflected in the cost control procedures and the support systems that are established and employed as a standard management design tool for your project.

- **1. Accurately Right Sizing the Building.** Building size is not only based upon each individual space, but also upon proper adjacencies and building circulation. This, in turn, has a direct impact on the net to gross square footage ratio of the building and ultimately the building size. Our team will prepare a thorough analysis of the building program and appropriate support space to confirm that we have the building right sized for current and future needs.
- **2. Getting Out of the Ground.** One of the biggest areas for unforeseen costs is the condition of the soil, the proper identification of all utilities, and any underground conflicts that may exist. Our team recommends additional subsurface soil testing in the areas proposed for construction to closely verify sub surface conditions to try and minimize the impact they may have during construction.
- **3. Structural Systems.** Based upon many factors such as critical first responder design component importance, wind speed, design pressures, distance from the coast, soil conditions, are just a few of the major aspects used to select and design the appropriate structural system. This can sometimes be influenced by market conditions. Our team's experience designing resilient and mission critical buildings in Florida and across the nation give us a better understanding of the appropriate system.
- **4. MEP Systems.** Public Safety Facilities generally require redundant mechanical, electrical, and plumbing systems that support the function of the building. The selection of these systems, coupled with a discussion on life cycle costs, controls, and level of institutional quality, will have a bearing on cost. The amount of space within the building that has redundant power, technology, HVAC, potable water and back up sewer will be determined based on discussions with Emergency Management and the county.
- **5. Sustainable Design.** The level of sustainable design will directly impact the cost of the facility. It could drive decisions towards innovative mechanical systems with a higher initial cost, but improved life cycle cost. Dewberry and our subconsultants will work with Levy County to meet its sustainability goals in a cost-effective manner based on life cycle cost analysis.
- **6. Interior Finishes.** Interior finishes are first things that people notice when they first enter a facility. It is important to understand that finishes are important to the quality of any facility. EOC's are used 24 hours a day, 365 days a year. The finishes need to be quality finishes that are resilient because of the wear and tear of a 24-hour facility. The quality levels of the floor, wall, and ceiling materials need to be assessed regarding their impact on cost, durability, and maintainability.
- **7. Technology/Security/AV.** An EOC and 911 Dispatch Center relies heavily on technology for many day-to-day activities. Dewberry will provide the necessary knowledge to design and specify the infrastructure needed to support the facilities technology requirements within the budgetary constraints of the project.

Cost control does not stop after design. It is critical to control cost creep during construction. This is supported by thorough and coordinated construction documents which accurately reflect the scope of work and is reinforced by proactive construction administration processes. Once the project is under construction, Dewberry will work closely with the county to reduce change orders by thoroughly reviewing RFI's and providing responses which refer to the Contract Documents for resolution to the greatest extent possible.

















### **Public Safety Design Principles**

Public safety design and architecture is successful when it serves the needs of the residents, emergency management and County leadership, while promoting an alliance among all parties. Dewberry achieves successful results with use of a series of guiding design principles throughout the project.

#### **Civic Values**

Respect the neighborhood context. Both the EOC and 911 Dispatch should be seen as a "place" and not isolated buildings. Emphasize leadership in energy conservation and environmental sustainability through architectural design and selection of materials. Optimize open space and minimize building footprint, parking, on-site roads, and service drives as much as possible.

#### **Siting and Orientation**

Make sure the buildings are spatially coherent to facilitate the flow of people to and from and create "positive" outdoor spaces with pedestrian emphasis.

#### **Building Form**

Develop massing strategies appropriately scaled to the site and neighborhood.

#### **Redundant Design Standards**

An Emergency Operations and Dispatch Center must maintain operations during natural and man-made events, meaning the facility will require continuous service from all building utilities including Potable Water, Sanitary Sewer, HVAC, Power, Data and Communications. The design team will review with all stakeholders to confirm that the project is meeting the anticipated codes, grant criteria, program, and client expectations to maintain continuous operations. This list of items should include:

- Provide utility systems backup in the event of prolonged power, water, data, and sewage outages.
- Consider providing minimum of 72 hrs of emergency generator back up electrical power.
- Our civil engineers will estimate what the gallon/ day of sewage storage for anticipated building loads during activation. These occupancy levels should be reviewed with the client group.
- Provide fresh water storage to serve the number of occupants assumed
- Redundant HVAC systems for communications PSAP programs and associated equipment
- Provide UPS (Uninterrupted Power Source) back-up in mind to cover momentary power loss during transfer.

- Redundant Feeds for Data from two distinct service points
- Protect generators, HVAC equipment, pumps, etc from impact.

#### **Living and Sleeping Quarters**

Bunkrooms foster camaraderie at the facility by preventing staff members from isolating themselves from others. With a growing number of females in the public safety/emergency management arena it will important to consider how dormitory spaces are organized to address this changing demographic. The dormitory areas can be separated into several individual units to allow for separation of gender and flexibility of staff. Individual and adequate storage space can be incorporated with under bunk draws, wall lockers, or other furniture solution. Additionally, semi-private bunk areas can allow for more efficient delivery of conditioned air and more efficient egress for calls.

# Activation Plan and Post Disaster Planning

During and after activation, the Emergency Operations Center will have additional occupants at the Public Safety Complex due to the number of staff occupying the building, outside agencies, government officials, and other staging needs associated with Emergency Response Operations. Through the design process impacts to parking will be considered, with accommodations for overflow parking being considered. This will include staging areas for emergency response vehicles, temporary structures, media vehicles, potential County utility response teams, and an area for supply delivery depending on the needs of the Activation and Post Disaster plan. Dormitories, lockers, showers and restrooms as well as food and dining needs will be needed, along with storage of dry goods, non-perishables, prepackaged MRE meals, drinking water, and bulk supplies.

### **Survivable Design Considerations**

An EOC and 911 Dispatch are considered "Essential Facilities". The functional requirements of an "Essential Facility", specifically an Emergency Operations Center and Dispatch require special attention to survivable needs that include the building programming, building design, site selection/design, and building system selection/design. The "Essential Facility" building type requires a systematic approach to review and determine code mandated requirements, guideline requirements, and possible grant requirements that must be met to verify funding continuity, and specific client requirements. The design team will review the survivable design fundamentals with all key stakeholders to give a better understanding of the process of risk assessment.

### **Envelope Survivability**

There are multiple building envelope requirements, building structural loads, and envelope survivability requirements for an Emergency Operations Center and 911 Dispatch center. These codes and Standards Include: FEMA 361, ICC 500, IBC, NFPA 1221, ASTM E1996/E1886, and ASCE 7 as well as the AHJ's (Authority Having Jurisdictional) requirements. An Emergency Operations Center is considered by definition to be an "Essential Facility" by the IBC. FEMA 361 or Alternate Review Methods per ASCE 7 far exceed the IBC Essential Facility requirements. The codes do not always agree and may overlap and conflict. The design team will have the AHJ determine which codes apply and which are elective codes due to Grant Application or client requirements.

Depending on the level of hardening the building support structure and enclosure may need to incorporate protective materials and system design, including, but not limited to the following: progressive collapse protection of FEMA 361. This would include hardened wall construction, specialized glazing systems, protective intake ventilation, and other exterior components. Blast requirements, impact protection, wind speed determination, lateral load bracing, seismic loads, rain loads, and other envelope design systems will also be defined by the required codes.

A large portion of the envelope includes the exterior wall design usually constructed of concrete materials or other survivable systems and openings are protected from impact. The design team will work with all stakeholders including the Director of Emergency Services to determine the appropriate level of protection and develop estimates of the construction costs to achieve those requirements.



# Process to Achieve Success and Design Excellence

Our design methods, although based on previous experiences, are tailored to the type, scale and complexity of each project and client. Our unique strategy of working with the users and leadership guides us towards innovative solutions that are the product of a careful process. Participation by all interested parties in a proposed facility provides a better understanding and pride of authorship in the final process and product.

First and foremost for all of our municipal and public safety agency clients, success is typically gauged by the questions, "Did the project come in on budget and was it delivered on time?" 


### **CURRENT AND PROJECTED WORKLOADS**


