(2:58)Clerk of Court, Matt Brooks recognized Deanna Dobbins for 36 years of service with the Clerk's Office. He then provided a report to the Commissioners from the county auditors, James, Moore & Company regarding county funded court related functions.

(4:23)Town of Bronson representative, Virginia Phillips spoke to the Board requesting assistance with various projects/repairs within the Town needing attention.

(9:53)Comm. Mills read into public a letter received from Levy County resident, Linda Poulin regarding code violations received.

## **BUSINESS OR INFORMATIONAL ITEMS**

#### **COUNTY MANAGER**

Mary-Ellen Harper

A. (12:29)Requesting Board approval to appoint a representative to serve on the Juvenile Justice Circuit Advisory Board (CAB). Comm. Kennedy volunteered to serve on this Board.

Comm. Hodge made a motion to appoint Comm. Kennedy to serve on the Juvenile Justice Circuit Advisory Board. Second was made by Comm. Hiers and the MOTION CARRIES.

B. (13:59)Requesting the Board receive First Quarter Fiscal Year Quarterly Reports for October 1, 2024 – December 31, 2024 from the Building and Code Enforcement Departments.

An update was provided to the Board from the Building/Development Department by Bo Cox and the Code Enforcement update was given by Dave Banton.

C. (19:45)Requesting Board approval of RESOLUTION 2025-3; A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF LEVY COUNTY, FLORIDA, AUTHORIZING THE CREATION AND MAINTENANCE OF A COUNTY ADMINISTRATIVE CODE; AND PROVIDING AN EFFECTIVE DATE.

Comm. Hodge made a motion to approve Resolution 2025-3 as requested. Second was made by Comm. Kennedy and the MOTION CARRIES.

D. (21:37)Requesting Board approval of a new Organizational Structure to include Division Directors. Mrs. Harper stated the current budget includes an appropriation of \$74,000 for a Public Information Officer. As the position is vacant, this funding can be reallocated to fund the proposed pay scale for the new organizational structure, rather than hiring an Assistant County Manager.

Audience member, Linda Cooper spoke regarding this item and requested copies of the job descriptions for the Division Director positions. She then inquired if the total salary budgeted for the PIO of \$110,000, which includes benefits, would be distributed, or just the \$74,000, and if each Division Director will receive an increase.

Comm. Mills responded the amount of \$74,000 would be distributed among Division Directors, but not all would receive an increase.

Comm. Kennedy made a motion to approve the Organizational Structure including Division Directors as requested. Second was made by Comm. Hodge and the MOTION CARRIES.

E. (29:51)Requesting the Levy County Board of County Commissioners to receive an update on the removal of unauthorized signs.

Real estate agents in attendance who spoke regarding the placement and removal of signs were: Brandi Hilliard, Linda Jane Kramer, Charlene Hovey, Cookie King, Fred Wynans, and Burgandy Arrington. Jeff Hardison also spoke regarding the level of enforcement of sign removal up until a Workshop is scheduled.

Following discussion, the Commissioners agreed to schedule a Workshop for further discussion and public input. Until the Workshop date, the only sign enforcement will be for reported complaints.

F. (1:11:00)Requesting the Board provide direction regarding the H.A. White Gymnasium. Mrs. Harper provided photos of water damage and deterioration of the building and explained repairs in order for it to be usable again would be a large expense.

Audience members who spoke suggesting the Board consider other options rather than demolishing the building were: Rachel Weeks, Virginia Phillips, Sherrie Schuler, Beatrice Roberts, Mac McKoy, Carolyn Hunt, Renate Cannon, Linda Cooper, Natalie Thomas, and Dana Henson.

Comm. Kennedy made a motion to have the gymnasium demolished. Second was made by Comm. Hodge and the MOTION CARRIES.
