



The largest building on the site is the Core Building. This is a 41,000 sf hurricane hardened tilt-up concrete building that contains office space and warehouse storage space for the Public Works and Public Utilities departments. This building is built to withstand up to 223 mph (ultimate) wind speeds and is intended to survive a Category 5 hurricane. It will therefore allow the County to continue operation through a hurricane and provide critical infrastructure and utility support immediately following a major storm event. The building contains open office areas for County staff as well as break rooms, toilet and shower facilities, training rooms and a muster room for gathering employees to distribute critical information. Approximately 60% of the building is warehouse space to store supplies and equipment used by county utility staff. The building is connected to back-up emergency generator power.

The Fleet Building is a 14,000 sf pre-engineered metal building with four enclosed vehicle service bays as well as two covered exterior service bays. In addition, the building contains offices, toilet and shower facilities, a break room and a vehicle parts storage room. The bays contain vehicle lifts capable of lifting up to 100,000 pounds, a 2-ton overhead traveling hoist system, and distribution systems for compressed air and various lubricants. This building is built to withstand up to 223 mph (ultimate) wind speeds and is intended to survive a Category 5 hurricane. It will therefore allow the County to continue operation through a hurricane and provide critical infrastructure and utility support immediately following a major storm event.

The building contains open office areas for County staff as well as break rooms, toilet and shower facilities, training rooms and a muster room for gathering employees to distribute critical information. Approximately 60% of the building is warehouse space to store supplies and equipment used by county utility staff. The building is connected to back-up emergency generator power.

The Fleet Building is a 13,000 sf pre-engineered metal building with four enclosed vehicle service bays as well as two covered exterior service bays. In addition, the building contains offices, toilet and shower facilities, a break room and a vehicle parts storage room. The bays contain vehicle lifts capable of lifting up to 100,000 pounds, a 2-ton overhead traveling hoist system, and distribution systems for compressed air and various lubricants. The Fleet building will enable the County Fleet Maintenance department to service and maintain their fleet of service and emergency vehicles. The building is connected to back-up emergency generator power. The site also contains a diesel and gasoline fueling station for County vehicles as well as various outbuildings to provide covered storage for materials and equipment.

The Consolidated Hardened Maintenance Facility (CHMF) in Valrico is a 26-acre campus supporting Hillsborough County's Public Works, Public Utilities, and Fleet Maintenance Departments. The 42,000 SF Core Building, a hurricane-hardened tilt-up concrete structure, is designed to withstand 223 mph winds (Category 5 hurricanes), ensuring uninterrupted operations during major storms. 


**WORKLOAD CAPACITY CHART**
