**A RESOLUTION OF THE BOARD OF COUNTY
COMMISSIONERS OF LEVY COUNTY, FLORIDA
AUTHORIZING THE EXECUTION AND SUBMISSION OF A
GRANT APPLICATION AND SUPPORTING DOCUMENTS AND
ASSURANCES TO THE BOARD OF COUNTY COMMISSIONERS
OF LEVY COUNTY; DESIGNATING AUTHORIZED
SIGNATORIES AND A COUNTY PROJECT MANAGER; AND
PROVIDING AN EFFECTIVE DATE.**

WHEREAS, the Board of Commissioners of Levy County is eligible to receive a Transportation Disadvantaged Trip & Equipment Grant and to undertake a transportation disadvantaged service project as authorized by Section 427.0159, Florida Statute, and Rule 41-2, Florida Administrative Code; and

WHEREAS, the Applicant has the fiscal and managerial capability and legal authority to apply for and accept grants and make purchases and/or expend funds pursuant to grant awards made by the Florida Commission for the Transportation Disadvantaged; and

WHEREAS, this Resolution is required to comply with the grant conditions of the Florida Commission for the Transportation Disadvantaged.

NOW, THEREFORE, BE IT RESOLVED, by the Board of County Commissioners of Levy County, Florida (the "Board"), that:

1. The submission of the Transportation Disadvantaged Trip & Equipment Grant Agreement application together with all required supporting documents, certifications, and assurances to the Florida Commission for the Transportation Disadvantaged, for the purpose of transportation disadvantaged trip reimbursement is hereby approved.
2. The County Manager, Grants and Finance Manager, and/or the Community Services Division Director are designated and authorized on behalf of the Applicant to: sign and submit the Transportation Disadvantaged Trip & Equipment Grant Agreement application and all required supporting documents, and any application amendments thereto; and to give all required certifications and assurances for purposes of the grant application.
3. If the Transportation Disadvantaged Trip & Equipment Grant Agreement is awarded to the County and the County Commission approves the Grant Agreement, the Community Services Division Director is designated and authorized to serve as the County's Project Manager for the Transportation Disadvantaged Trip & Equipment Grant Agreement.
4. This Resolution shall take effect immediately upon adoption.
