A. Requesting Board discussion and approval of the 2025 Legislative Priorities.

B. Requesting the Levy County Board of County Commissioners receive a presentation on the proposed Cross Florida Barge Canal Boat Ramp and to consider approving a letter of support for this legislative initiative proposed by Citrus County. The Citrus County Board of County Commissioners has approved the proposed Cross Florida Barge Canal Boat Ramp as one of their 2025 Legislative Priorities and believe this project is of significant regional importance, including for the residents of Levy County.

James Toy, Citrus County Intergovernmental Affairs Manager spoke to the Board of the proposed Cross Florida Barge Canal Boat Ramp.

Audience members who spoke against the Board supporting this item: Carl Zervis, Linda Cooper, Ken Rollerson. Will Ary, Yankeetown Town Manager stated the Town of Yankeetown is in favor of this project.

Following discussion, the Board agreed by consensus to request more information on this project before approving a letter of support.
