The primary purpose of this survey is for permit renewal for mining operations. The final deliverable should include a sign and sealed stable based film (mylar), 10 certified prints, a copy of the field notes, an AutoCAD file Release 2005, a copy of the raw data and coordinate files in text format. This data may be utilized to possibly prepare additional exhibits that may be required in the permitting process.
- 2. <u>Proposal.</u> Consultant submitted a proposal for the Project, dated 26 April 2021, the applicable portions of which are attached hereto (the "Proposal"). The Proposal is divided into Consultant's proposal narrative, fee proposal submitted to County which consists of pages one (1) and two (2), plus General Conditions as Exhibit A to the two-page Proposal. Pages 1 and 2 of the Proposal are incorporated herein by this reference. The General Conditions attached to Consultant's Proposal are not attached to this Task Assignment, are specifically not included as part of this Task Assignment and will not be binding on the County.
- 3. <u>Scope of Work.</u> Pursuant to the provisions of the Continuing Professionals Services Agreement and this Task Assignment, Consultant shall provide all of the services and materials described in the Proposal, at the level of workmanship and quality set out in the Continuing Professional Services Agreement.
- 3. <u>Compensation.</u> County shall compensate Consultant for its services pursuant to this Task Assignment a not to exceed amount of Thirty-Eight Thousand Seven Hundred Dollars (\$38,700), in accordance with the fee set forth in the Proposal. Invoices or requests for payments to Consultant shall be made in accordance with Florida Local Government Prompt Payment Act, section 218.70 through 218.79, Fla. Stat.
- 4. <u>Time.</u> Consultant shall perform its services for this Task Assignment within one hundred twenty (120) calendar days after execution of this Task Assignment by both parties. In the event of inclement weather that prevents Consultant from performing the services hereunder, the time frame for performance of services will be extended by the number of such inclement weather days.
- 5. <u>Conflict.</u> In the event of a conflict between any of the provisions of the documents which make up this Task Assignment, the documents shall be given priority in the following order: 1) this Task Assignment; 2) the Continuing Professional Services Agreement; 3) the portions of the Proposal

We appreciate the opportunity to present the following proposal for your consideration. It is our understanding that you are in need of a specific purpose survey for permit renewal at the Levy County Gulf Hammock Lime Rock Mine site. George F. Young, Inc. (GFY) will complete this service to be in compliance with the State of Florida Standards of Practice set forth in Florida Administrative Code, Chapter 5J-17 adopted by the Florida Board of Professional Surveyors and Mappers pursuant to Section 472-027 Florida Statutes.

The scope of services is as follows:

- -Mobilize a field crew to the site retrace the provided Mills Engineering survey dated August 3rd, 2015. Prepare a boundary survey utilizing the Mills Survey and any additional supporting documents.
- -Monument the 50' Access Easement boundary, 25' right and left of described centerline from Buck Island Road to an intersection with the northerly line of the mine boundary. Monuments will be ½" steel rods with Caps stamped "GFY LB021".
- -Collect topographic information along the entire outermost boundary lines and at +/-25' interior to the boundary. Elevations will be collected in +/-100' intervals along the boundary. Elevations will be shown on the North American Vertical Datum of 1988 (NAVD88).
- -Collect topographic information along the earthen berm along the northerly and easterly boundary of the area included in the Michael L. Pardue survey also shown on the Mills Sketch as the Active Mining Area, and the berm along the westerly extension of the northerly line lying west of the access easement. Topographic information will be collected at the toe, top, and toe of the berm structure at +/- 100' intervals. Elevations will be shown on the North American Vertical Datum of 1988 (NAVD88).
