A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF LEVY COUNTY, FLORIDA, AMENDING RESOLUTION 2015-22, ADOPTING A REVISED SCHEDULE OF FEES AND CHARGES FOR ANIMAL SERVICES DEPARTMENT; PROVIDING AN EFFECTIVE DATE.

RECITALS

WHEREAS, on June 2, 2015, the Board of County Commissioners (“the Board”) adopted Resolution 2015-22, prescribing fees for services performed or costs incurred by the Levy County Animal Services Department (“the Department”), and providing for payment and waivers of such fees; and

WHEREAS, the Board now desires to amend the Schedule of Fees adopted by Resolution 2015-22 to add new fees required for additional services performed or costs incurred by the Department; and

WHEREAS, the Board finds that it is in the best interests of the County to amend the Schedule of Fees and charges adopted by Resolution 2015-22 as provided herein;

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF LEVY COUNTY, FLORIDA:

1. The Schedule of Fees adopted by and attached to Resolution 2015-22 shall be replaced in its entirety by the Schedule of Fees attached to this Resolution 2020- [REDACTED] and incorporated herein by this reference.

2. All other provisions of Resolution 2015-22 not specifically amended by this Resolution shall remain unchanged.

3. All terms used in this Resolution and the attached Schedule of Fees that are defined in Ordinance 2020-_____ shall have the same meaning as set forth in Ordinance 2020-_____ unless the context clearly indicates otherwise.

4. The effective date of this Resolution shall be the date of adoption.

Second occurrence	\$35.00
Third and subsequent occurrences	\$50.00
Impoundment/Kennel/Boarding/Maintenance Fee for dog or cat from incorporated area and brought by municipal representative	\$12.00 per animal
Microchip fee (if impound or adoption fee not applied or paid)	\$25.00
Vaccination fee (if adoption fee not applied or paid)	\$ 5.00
Kennel/Boarding/Daily maintenance	\$10.00 per day per animal
Quarantined animals – Kennel/Boarding/Daily Maintenance	\$12.00 per day per animal
Owner Surrender of Animal with Department Pickup of Animal	\$25.00 per animal
Community Cat Surrender by Community Cat Caregiver	\$12.00 per cat
Issuance of Annual Certificate of Registration for Dangerous Dog	\$100.00 per animal
Initial Registration and Annual Renewal of Registration for Irresponsible Pet Owner	\$100.00 per animal
Adoption Fees (includes spay/neuter, rabies vaccination, and microchip)	\$55.00 female dog \$40.00 male dog \$40.00 female cat \$25.00 male cat
Adoption Fee for animals spayed/neutered prior to Arrival at Levy County Animal Services Department	\$25.00 per animal
