- A. Requesting Board approval of Resolution 2023-47 adopting the Tentative Millage Rate for Levy County for the fiscal year commencing October 1, 2023 and ending September 30, 2024; and providing an effective date. The proposed Millage Rate is 9.0000 which represents a 9.67% increase over the rolled-back rate of 8.2062 mills.

Comm. Brooks asked if anyone in the audience wished to speak regarding the proposed Tentative Millage Rate. There was none.

Comm. John Meeks made a motion to approve Resolution 2023-47 adopting the Tentative Millage Rate at 9.0000 with the rolled-back rate of 8.2062 as presented. Second was made by Comm. Rock Meeks and the MOTION CARRIES.

- B. Requesting Board approval of Resolution 2023-48 adopting the Tentative Budget for Levy County of \$155,397,925 for the fiscal year commencing on October 1, 2023, and ending on September 30, 2024; and providing an effective date. Mrs. McLean stated this Tentative Budget had not changed since the presentation on August 1<sup>st</sup>, other than clerical corrections within the same funds.

Comm. Brooks asked if anyone in the audience wished to speak regarding the proposed Tentative Budget. There was none.

Comm. John Meeks made a motion to approve Resolution 2023-48 adopting the Tentative Budget as presented. Second was made by Comm. Hodge and the MOTION CARRIES.
