## LEVY COUNTY COORDINATOR

Mr. Dean informed the Board of Building Official, Bob Boulette's resignation and introduced the interim Building Official, Ben Maxson. Mr. Maxson spoke to the Board briefly expressing his intent to keep the Building Department running smoothly.

- A. PUBLIC HEARING – Requesting the Board to adopt Ordinance 2020-002 for the adoption of LSA 19-02 (Reference Number 20-01ESR). This is a large scale plan amendment with two (2) twenty (20) acre parcels just a few miles North of the Town of Inglis, Florida. The transmittal process was approved by DEO and all comments from surrounding agencies were positive.

### **TOURIST DEVELOPMENT**

## **TRANSIT**

Requesting Board approval of Resolution 2020-033 authorizing the filing of the Shirley Conroy Rural Capital Assistance Program Grant application. Mrs. Conley stated the funding amount requested is \$82,746.00 for one 23' vehicle which has 14 seats and accommodation for two wheelchairs. This vehicle will replace an older vehicle with over 250,000 miles.

Renate Cannon pointed out a typo in the Grant application to Comm. Brooks.

## **EMERGENCY MANAGEMENT**

## **LEVY COUNTY COVID-19 PHASED RE-OPENING GUIDE**

Comm. Brooks spoke regarding a Phased Re-Opening Guide draft which was provided for the Commissioners to review and discuss. It outlines re-opening procedures to have in place as soon as the State begins re-opening for the State of Florida.

Comm. Rock Meeks made a motion to approve the Levy County BOCC COVID-19 Phased Re-Opening Guide as presented contingent upon the State's re-opening guidelines. Second was made by Comm. John Meeks and the MOTION CARRIES.

Atty. Brown requested the Board make a separate motion to specifically authorize the Chairman to approve changes to the Emergency Order which will be brought back to the Board to be ratified.

Comm. John Meeks made a motion to authorize the Chairman to approve changes to the Emergency Order as stated by Atty. Brown. Second was made by Comm. Rock Meeks and the MOTION CARRIES.

## **COMMISSIONERS' REPORTS**

**Comm. John Meeks** shared with the Commissioners a letter he received from Senator Bradley addressing funding for programs going forward in Levy County. Senator Bradley listed the projects so the Commissioners may advocate for them as Governor DeSantis makes decisions on which may or may not continue.

**Comm. Rooks** inquired of the status of shelters for hurricane season from John MacDonald and if there would be any pet friendly shelters. Mr. MacDonald responded there are shelters planned for use and at least one pet friendly shelter would be available, as required. A written plan is already in place for pet friendly sheltering.

**Comm. Brooks** encouraged everyone to continue to be vigilant in their efforts to prevent the spread of the virus.
