**AN ORDINANCE OF LEVY COUNTY, FLORIDA, AMENDING THE TEXT OF THE LAND DEVELOPMENT CODE TO ALLOW MOBILE HOMES AS A PERMITTED USE IN THE RR-3C ZONING DISTRICT; PROVIDING FOR INCLUSION IN THE CODE; PROVIDING A SEVERABILITY CLAUSE; PROVIDING A REPEALING CLAUSE; AND PROVIDING DIRECTION TO THE CLERK AND AN EFFECTIVE DATE.**
