

**RESOLUTION NUMBER 2023-10**

**A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF LEVY COUNTY, FLORIDA FINDING THAT CERTAIN COUNTY-OWNED TRANSIT VEHICLES ARE NO LONGER NEEDED FOR THE COUNTY’S TRANSIT SYSTEM; AUTHORIZING THE TRANSFER OF THE TRANSIT VEHICLES TO LEE COUNTY; AUTHORIZING THE EXECUTION OF ALL REQUIRED DOCUMENTATION; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, Levy County owns three transit vehicles that have been underutilized due to a driver shortage and the County has determined that these transit vehicles are not needed for the foreseeable future to serve the County's public transit system;

**WHEREAS**, the transit vehicles were acquired with federal funds through the Federal Transit Administration (the “FTA”), useful service life remains on the vehicles, and therefore, Federal interest remains attached to each vehicle;

**WHEREAS**, Levy County, with the prior approval of the FTA, may transfer transit vehicles with remaining useful service life to another FTA grant recipient;

**WHEREAS**, Lee County, a political subdivision of the State of Florida, operates a public transit service known as LeeTran, is an FTA grant recipient and has requested that the three transit vehicles be conveyed to Lee County for the purpose of putting the transit vehicles into service for LeeTran; and

**WHEREAS**, LeeTran and the Levy County Transit Department are coordinating the transfer with the FTA's regional office(s), and this Resolution is a required step in that process.

**NOW, THEREFORE, BE IT RESOLVED**, by the Board of County Commissioners of Levy County, Florida (the “Board”), that:

1. The following described transit vehicles are no longer required by Levy County and the transfer of these vehicles to the **Lee County Board of County Commissioners** is hereby approved:

3. The Director of the Levy County Transit Department is authorized to execute all documentation necessary to effectuate the transfer authorized by this Resolution and in accordance with the transfer process required by the FTA.
4. This Resolution shall take effect immediately upon adoption.
