

**RESOLUTION  
NUMBER 2024-70**

**A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF LEVY COUNTY, FLORIDA, AMENDING THE FINAL BUDGET FOR FISCAL YEAR 2024-2025 IN THE AMOUNT OF \$93,750 DUE TO ADDITIONAL GRANT REVENUE FOR PURCHASE OF SOLID WASTE EQUIPMENT; PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the Board of County Commissioners of Levy County, Florida on September 17, 2024 held a public hearing as required by Section 200.065, Florida Statutes, and adopted Resolution 2024-50 approving the Final Budget for Fiscal Year 2024-2025 (the "FY24-25 Budget"); and

**WHEREAS**, pursuant to Section 129.06(2), Florida Statutes, this Resolution is required in order to amend the FY24-25 Budget.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of Levy County, Florida, that:

1. The FY24-25 Budget is amended as follows:

The Landfill Operations Fund (Fund No. 402) is increased by \$93,750 due to receipt of additional revenue from a Small County Consolidated Solid Waste Management State Grant for purchase of a Mac Trailer as set forth in the budget amendment form attached to and made a part of this Resolution.

2. This Resolution shall take effect immediately upon its adoption.
