**A RESOLUTION OF THE BOARD OF COUNTY  
COMMISSIONERS OF LEVY COUNTY, FLORIDA,  
AMENDING THE FINAL BUDGET FOR FISCAL YEAR  
2024-25 IN THE AMOUNT OF \$120,344 TO APPROPRIATE  
FUNDS FOR DEVELOPMENT DEPARTMENT OFFICE  
RENOVATIONS; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the Board of County Commissioners of Levy County, Florida on September 17, 2024, held a public hearing as required by Section 200.065, Florida Statutes, and adopted Resolution 2024-52 approving the Final Budget for Fiscal Year 2024-2025 (the "FY24-25 Budget"); and

**WHEREAS**, pursuant to Section 129.06(2), Florida Statutes, this Resolution is required in order to amend the FY24-25 Budget.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of Levy County, Florida, that:

1. The FY24-25 Budget is amended as follows:

\$120,344 is appropriated from the Building Inspections and Safety Fund (Fund No. 134) in order to increase the specified expenditures in that Fund for the purpose of Development Department Office Renovations as set forth in the budget amendment form attached to and made a part of this Resolution.

2. This Resolution shall take effect immediately upon its adoption.
