A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF LEVY COUNTY, FLORIDA, AMENDING THE FINAL BUDGET FOR FISCAL YEAR 2023-2024; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Board of County Commissioners of Levy County, Florida on September 19, 2023, held a public hearing as required by Section 200.065, Florida Statutes, and adopted Resolution 2023-50 approving the Final Budget for Fiscal Year 2023-2024 (the "FY23-24 Budget"); and

WHEREAS, pursuant to Section 129.06(2), Florida Statutes, this Resolution is required in order to amend the FY23-24 Budget.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of Levy County, Florida, that:

The FY23-24 Budget is amended as follows:

The Misc Grants Fund (Fund No. 115) is increased by \$450,000.00 due to receipt of additional revenue from an FDOT Public Transportation Grant and those additional revenues are appropriated for new restrooms and a lighted kiosk at the George T. Lewis Airport, as set forth in the budget amendment form attached to and made a part of this Resolution.
