21	WHEREAS, in a public hearing held on March 2, 2021, the Board of County		
22	Commissioners of Levy County, Florida ("Board"), reviewed Application CZ 04-20 which		
23	requested a rezoning of 2.67 acres more or less from Neighborhood Commercial (C-2) to		
24	Rural Residential (RR), on property owned by Jerry W. Hyde and Judith A. Hyde, P.O. Box		
25	53, Old Town, FL 32680, which property is described as Lot 23, Block C, U.S. 19 NO. 1		
26	ADDITION, according to the plat thereof as recorded in Plat Book 2, Page 62, Public		
27	Records of Levy County, Florida; and		
28	WHEREAS, the applicants, Jerry W. Hyde and Judith A. Hyde, seek a rezoning to		
29	construct a residential home on the subject property; and		
30	WHEREAS, the Levy County Planning Commission and the Board conducted public		
31	hearings on December 7, 2020, and January 5, 2021, respectively, regarding a Small		
32	Scale Future Land Use Map Amendment from a designation of Commercial (C) to Urban		
33	Low Density Rural Residential (ULDR) on the Levy County Future Land Use Map for the		

subject property (herein "the FLUM Amendment"), which FLUM Amendment approved by 1 the Board by its adoption of Ordinance 2021-01 on January 5, 2021; and 2 WHEREAS, the Levy County Planning Commission conducted a public hearing on 3 Application CZ 04-20 on February 8, 2021, and found the Application to be consistent with 4 5 the Levy County Comprehensive Plan and recommended approval of the Application; and WHEREAS, after due consideration, the Board of County Commissioners has found 6 that the request is consistent with the Levy County Comprehensive Plan and has 7 determined it to be in the best interest of the public to rezone the subject property from C-2 8 9 to RR. NOW, THEREFORE, BE IT ORDAINED by the Board of County Commissioners of 10 Levy County, Florida: 11 **SECTION 1.** That the following application for a rezoning is hereby approved: 12 Application CZ 04-20 rezoning 2.67 acres more or less of property from 13 Neighborhood Commercial (C-2) to Rural Residential (RR) on property 14 owned by Jerry W. Hyde and Judith A. Hyde, described as Lot 23, Block C, 15 U.S. 19 NO. 1 ADDITION, according to the plat thereof as recorded in Plat 16 Book 2, Page 62, Public Records of Levy County, Florida. 17 18 **SECTION 2.** The zoning for this property shall run with the property and shall apply 19 20 to any subsequent owners, heirs and assigns. SECTION 3. This ordinance shall not be included in the Code of Ordinances of 21 22 Levy County, Florida. This ordinance shall have all legal force and effect as a duly adopted 23 ordinance of Levy County, Florida. **SECTION 4.** This ordinance shall take effect upon the effective date of Ordinance 24 2021-01, provided that it has been filed in the office of the Secretary of State, State of 25 Florida. 26 27 2
