**A RESOLUTION OF THE BOARD OF COUNTY  
COMMISSIONERS OF LEVY COUNTY, FLORIDA,  
AMENDING THE FINAL BUDGET FOR FISCAL YEAR  
2020-2021; PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the Board of County Commissioners of Levy County, Florida, ("the Board") on September 22, 2020 held a public hearing as required by Section 200.065, Florida Statutes, and adopted Resolution 2020-106, adopting the Final Budget for Fiscal Year 2020-2021; and

**WHEREAS**, an amendment to the 2020-2021 Final Budget is required as a result of unanticipated funds received in the 2020-2021 Final Budget and received for particular purposes(s); and

**WHEREAS**, on March 2, 2021, the Board considered this Resolution pursuant to the provisions of Section 129.06(2)(d), Florida Statutes, in order to amend the Fiscal Year 2020-2021 Final Budget to reflect the changes required; and

**NOW, THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of Levy County, Florida, that:

1. The Fiscal Year 2020-2021 Final Budget adopted by Resolution 2020-106, is hereby amended as follows:

The Maintenance Budget shall be increased by \$102,734.00, as reflected in the attached budget amendment form.

2. This resolution shall take effect immediately upon its adoption.
