

**RESOLUTION NUMBER 2026-15**

**A RESOLUTION OF THE BOARD OF COUNTY  
COMMISSIONERS OF LEVY COUNTY, FLORIDA  
AUTHORIZING THE EXECUTION AND SUBMISSION OF A  
GRANT APPLICATION AND SUPPORTING DOCUMENTS AND  
ASSURANCES TO THE FLORIDA COMMISSION FOR THE  
TRANSPORTATION DISADVANTAGED; DESIGNATING  
AUTHORIZED SIGNATORIES AND A COUNTY PROJECT  
MANAGER; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the Florida Commission for the Transportation Disadvantaged has established the Shirley Conroy Rural Area Capital Assistance Grant (the “RCAP”), administered by the Florida Commission for the Transportation Disadvantaged, which provides grants to government entities for the specific purpose of reimbursing a portion of the cost to purchase capital equipment utilized to maintain or provide improved or expanded transportation services to the transportation disadvantaged; and

**WHEREAS**, Levy County Board of County Commissioners desires to apply for funding under the Program for the project known as the Shirley Conroy Rural Area Capital Assistance Grant, which will provide improved or expanded transportation services; and

**WHEREAS**, the County has the fiscal and managerial capability and legal authority to apply for and accept grants and make purchases and/or expend funds pursuant to grant awards made by the Florida Commission for the Transportation Disadvantaged; and

**WHEREAS**, this Resolution is required to comply with the grant conditions of the Florida Commission for the Transportation Disadvantaged.

**NOW, THEREFORE, BE IT RESOLVED**, by the Board of County Commissioners of Levy County, Florida (the “Board”), that:

1. The submission of the Shirley Conroy Rural Area Capital Assistance grant together with all required supporting documents, certifications, and assurances to the Florida Commission for the Transportation Disadvantaged for the purpose of purchasing capital equipment utilized to maintain or provide improved or expanded transportation services is hereby approved.
2. The County Manager, Grants and Finance Manager, and/or the Community Services Division Director are designated and authorized on behalf of the County to: sign and submit the Shirley Conroy Rural Area Capital Assistance grant application and all required supporting documents, and any application amendments thereto; and to give all required certifications and assurances for purposes of the grant application.
3. If the Shirley Conroy Rural Area Capital Assistance grant is awarded to the County and the County Commission approves the Grant Agreement, the Community Services Division Director is designated and authorized to serve as the County’s Project Manager for the Shirley Conroy Area Rural Capital Assistance Grant.
4. This Resolution shall take effect immediately upon adoption.
