

RESOLUTION NUMBER 2021-080

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF LEVY COUNTY, FLORIDA, APPROVING A PETITION TO VACATE, ABANDON, AND CLOSE A PORTION OF NE 27TH STREET, IN LEVY COUNTY, FLORIDA.

RECITALS

WHEREAS, a petition has been made by Ken Sheffield and Charlene Sheffield to vacate, abandon, discontinue and a portion of NE 27th Street from the East right of way line of NE 118th Terrace to the West right of way line of NE 120th Avenue, located in Green Hills Subdivision, a subdivision recorded in Plat Book 8, Page 13, Public Records of Levy County, Florida ("the Petition"); and

WHEREAS, the Board of County Commissioners ("the Board") set a public hearing to hear said Petition and notice thereof was published as required by law; and

WHEREAS, Sections 336.09, 336.10, and 336.12, Florida Statutes, authorize the vacating, abandonment, discontinuance, and closing of streets and roads, and any right of the County and of the public in and to any land or interest therein, by the Board; and

whereas, the property owners adjacent to the subject right of way, Ken Sheffield and Charlene Sheffield have indicated that they are the fee simple owners of a portion of the property abutting the right of way sought to be vacated, abandoned, discontinued and closed; and

WHEREAS, the Petition states that this vacation, abandonment, discontinuance, and closing of that portion of NE 27th Street, as described herein, will not affect the ownership, or the right of convenient access, of persons owning other properties in the area; and

WHEREAS, the Board has found that the right of way which is the subject of this Petition no longer serves a public purpose and is a proper subject for vacation, abandonment, discontinuance, and closing pursuant to Chapter 336, Florida Statutes.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Levy County, Florida:

- 1. The Board of County Commissioners hereby approves the Petition of Ken Sheffield and Charlene Sheffield, and hereby vacates, abandons, discontinues and closes that portion of NE 27th Street from the East right of way line of NE 118th Terrace to the West right of way line of NE 120th Avenue, located in Green Hills Subdivision, a subdivision recorded in Plat Book 8, Page 13, Public Records of Levy County, Florida, which is adjacent to properties owned by Ken Sheffield and Charlene Sheffield and other owners.
- 2. Notice of adoption of this resolution shall be published one (1) time, within thirty (30) days following its effective date, in one issue of a newspaper of general circulation published in Levy County. The proof of publication of notice of public hearing, this resolution as adopted, and the proof of publication of the notice of the adoption of this resolution shall be recorded in the deed records of Levy County.


