1. The Fiscal Year 2020-2021 Final Budget adopted by Resolution 2020-106, is hereby amended as follows:

2. The General Operations budget shall be increased by \$43,310.00, as reflected in the attached budget amendment form.

3. This resolution shall take effect immediately upon its adoption.
