RESOLUTION NUMBER 2024-11

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF LEVY COUNTY, FLORIDA, AMENDING THE FINAL BUDGET FOR FISCAL YEAR 2023-2024; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Board of County Commissioners of Levy County, Florida on September 19, 2023, held a public hearing as required by Section 200.065, Florida Statutes, and adopted Resolution 2023-50 approving the Final Budget for Fiscal Year 2023-2024 (the "FY23-24 Budget"); and

WHEREAS, pursuant to Section 129.06(2), Florida Statutes, this Resolution is required in order to amend the FY23-24 Budget.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Levy County, Florida, that:

1. The FY23-24 Budget is amended as follows:

\$64,345 is appropriated from the Capital Projects and Replacement Fund (Fund 301) in order to increase the specified expenditures in that Fund for the purpose of HVAC and sprinkler system repairs at the Levy County Detention Bureau as set forth in the attached budget amendment form.

2. This Resolution shall take effect immediately upon its adoption.
