

**TASK ASSIGNMENT 2024-2**

**ISSUED UNDER AN AGREEMENT FOR CONTINUING PROFESSIONAL SERVICES**

THIS TASK ASSIGNMENT is issued by LEVY COUNTY, a political subdivision of the State of Florida (the "County") to ECS FLORIDA, LLC, (the "Consultant"), pursuant to the Agreement between Levy County and ECS Florida, LLC, for Continuing Professional Services dated November 21, 2023 (the "Continuing Professional Services Agreement.") This Task Assignment is for Preliminary Threatened & Endangered Species Assessment, Preliminary Wetlands Determination, and Environmental Permitting Services for the Gulf Hammock Pit.

1. Scope of Services. Consultant shall provide all of the services and materials described in (the "Scope of Services") described in Consultant's proposal dated February 20, 2024 titled Proposal for Preliminary Threatened & Endangered Species Assessment, Preliminary Wetlands Determination, and Environmental Permitting Services (the "Proposal"), which is attached as Exhibit "A" (consisting of twelve pages.)

2. Compensation. County shall compensate Consultant for its performance of the Scope of Services for Task 1 Ecological Services for a lump sum fee of Nineteen Thousand Seven Hundred Fifty Dollars (\$19,750), Task 2 Protected Tree Inventory Services for a lump sum fee of Four Thousand Two Hundred Fifty Dollars (\$4,250), and Task 3 Environmental Permitting Services for Thirty Four Thousand Five Hundred Dollars (\$34,500) as set forth in the Proposal. Invoices or requests for payments to Consultant shall be made in accordance with the Florida Local Government Prompt Payment Act, sections 218.70 through 218.79, Fla. Stat.

3. In the event of a conflict between the documents attached or incorporated by reference to this Task Assignment, the documents will be given precedence in the following order

First: This Task Assignment

Second: The Proposal attached as Exhibit "A"; and

Third: The Continuing Professional Services Agreement.

All other terms of the Continuing Professional Services Agreement not in conflict with this Task Assignment shall apply to Consultant's services to be provided under this Task Assignment and County's obligations under this Task Assignment.
