Background: The Levy County Planning Commission originally met on January 8, 2024 and voted 4-0 to recommend approval of Quasi-judicial PETITION No. FP 23-06 known as M&T Family Homestead, to the Levy County Board of County Commissioners. However upon further evaluation with Legal, Engineering and Road departments, it was decided that a subdivision variance would be needed. So staff continued the final plat to a date and time certain of February 20th at 6pm and then continued it again to a date and time certain of March 5, 2024 at 5:45 pm so the applicant could apply for the variance.
