#### RESOLUTION NO. 2018-069

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF LEVY COUNTY, FLORIDA, ELECTING TO AUTHORIZE ONE OR MORE EXCLUSIVE FRANCHISES FOR THE PROVISION OF SOLID WASTE COLLECTION SERVICES TO RESIDENTIAL AND NON-RESIDENTIAL PROPERTIES IN THE COUNTY OR TO PROVIDE SUCH SERVICES ITSELF OR THROUGH ANOTHER LOCAL GOVERNMENT; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Board of County Commissioners of Levy County, Florida (hereinafter, the "Board"), finds that the proper collection, disposal, recycling and management of solid waste, including recyclable and recovered materials (hereinafter "solid waste"), is necessary for the health, safety, and welfare of the citizens of Levy County, Florida; and,

WHEREAS, Levy County does not currently provide for the collection of solid waste in the County either directly or through franchise agreements with solid waste haulers; and

WHEREAS, Section 403.70605, Florida Statutes, Section 125.01, Florida Statutes, and other applicable provisions of law authorize Levy County to enter into franchise agreements for the collection of solid waste or to provide such services itself or through another local government; and

WHEREAS, Levy County intends to use such authority; and

WHEREAS, Levy County has, pursuant to Section 403.70605, Florida Statutes, mailed notice of the public hearing to those solid waste haulers doing business in Levy County; and

WHEREAS, in accordance with the provisions of Section 403.70605, Florida Statutes, notice was given by newspaper publication, and Proof of Publication is attached hereto as Exhibit A; and,

WHEREAS, a public hearing was held on December 18, 2018, and comments and objections of all interested persons have been heard and considered by the Board as required by Section 403.70605, Florida Statutes.

# NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF LEVY COUNTY, FLORIDA, AS FOLLOWS:

- 1. The Levy County Board of County Commissioners may authorize one or more exclusive franchises for the provision of solid waste collection services to residential and/or non-residential properties or provide such services itself or through another local government. This notice is intended to comply with the requirements of Section 403.70605, Florida Statutes, that the County intends to provide these services, which may displace some solid waste companies.
- 2. The Board hereby directs the County Coordinator to provide notice of the Board's intent as expressed in this resolution to solid waste haulers operating within the County in accordance with Section 403.70605, Florida Statutes.
- This Resolution shall take effect immediately upon its adoption.


