INTERLOCAL AGREEMENT

THIS AGREEMENT made and entered into this 21st day of January, 2003, by and between MARION COUNTY, a political subdivision of the State of Florida, hereinafter referred to as MARION COUNTY and LEVY COUNTY, a political subdivision of the State of Florida, hereinafter referred to as LEVY COUNTY.

WITNESSETH

WHEREAS, the Legislature of the State of Florida, pursuant to Chapter 69-1298, Laws of Florida, created the Rainbow Lakes Estates Municipal Service District consisting of unincorporated areas lying partly in MARION COUNTY and partly in LEVY COUNTY shown as Rainbow Lakes Estates; and

WHEREAS, Section 3 of Chapter 69-1298, Laws of Florida, provides that the Board of County Commissioners of Marion County, Florida shall constitute the district board of said Rainbow Lakes Estates Municipal Service District and shall act for and on behalf of said District; and

WHEREAS, Section 7, Chapter 69-1298, Laws of Florida, authorizes the Board of County Commissioners of Levy County to delegate to and contract with the Board of County Commissioners of Marion County for the administration of Chapter 69-1298 and the furnishing of municipal services as provided for in said law by the Rainbow Lakes Estates Municipal Service District and the district board to the area of said district lying within the boundaries of Levy County, Florida; and

WHEREAS, LEVY COUNTY AND MARION COUNTY decided by means of this Agreement to provide for the administration of Chapter 69-1298, Laws of Florida, and the furnishing of municipal services to the LEVY COUNTY portion of that Rainbow Lakes Estates Municipal Service District.

NOW, THEREFORE, for and in consideration of the mutual terms, covenants, and conditions herein contained to be compiled with by the parties hereto, the parties hereto contract and agree as follows:

1. LEVY COUNTY hereby delegates pursuant to the Resolutions of the Board of County Commissioners of Levy County, a copy of which is attached hereto as Exhibit "A", to provide for the purpose of administration of Chapter 69-1298, Laws of Florida, and the furnishing of administrative services in that portion of Rainbow Lakes Estates Municipal Service District, lying within the unincorporated areas of Levy County.
2. MARION COUNTY hereby agrees to administer Chapter 69-1298, Laws of Florida, and to furnish municipal services as provided for in said Chapter 69-



1298, Laws of Florida, to the unincorporated areas of LEVY COUNTY lying within the Rainbow Lakes Estates Municipal Service District and services to be provided at the discretion of MARION COUNTY and continuing upon availability of funds. MARION COUNTY will consider input from LEVY COUNTY and the Advisory Committee for Rainbow Lakes Estates Municipal Service District in the administration of Chapter 69-1298, Laws of Florida, and the provision of municipal services.

3. This Agreement shall remain in full force and effect from October 1, 2002 through September 30, 2012. Any funds collected by Levy County for the purposes of providing services to the Rainbow Lakes Estates Municipal Service District prior to the effective date of this agreement shall be remitted to the district board.
4. Either party may terminate this Agreement by giving the other party written notice of its intention to terminate as least sixty (60) days prior to the date of termination.




