Current inventory of cutaway vehicles, that are used on a daily basis, is 10. There are 6 operators and the agency is in the application process to hire one additional driver. This will leave only 3 cutaway vehicles for backup. Of those 3 vehicles, two are over 200,000 miles and by year end another two of the 10 will be at or over the 200,000 miles. The age of the vehicles in service from the oldest, 8 years to the newest being two years old. The average mileage per day, per vehicle is 177 miles, with the current 6 operators. With the additional operator, more trips can be provided. The cost of repairs and maintenance has increased within the past year due to the age of several of the vehicles, for repairs that cannot be foreseen. With the addition of a new vehicle, one of the older, high mileage vehicles will not need to be used as often. With the unknown time frame for receiving new vehicles, we could be facing another year or longer using the older vehicles on a daily basis, when the newer vehicles are being serviced or down for repairs.
