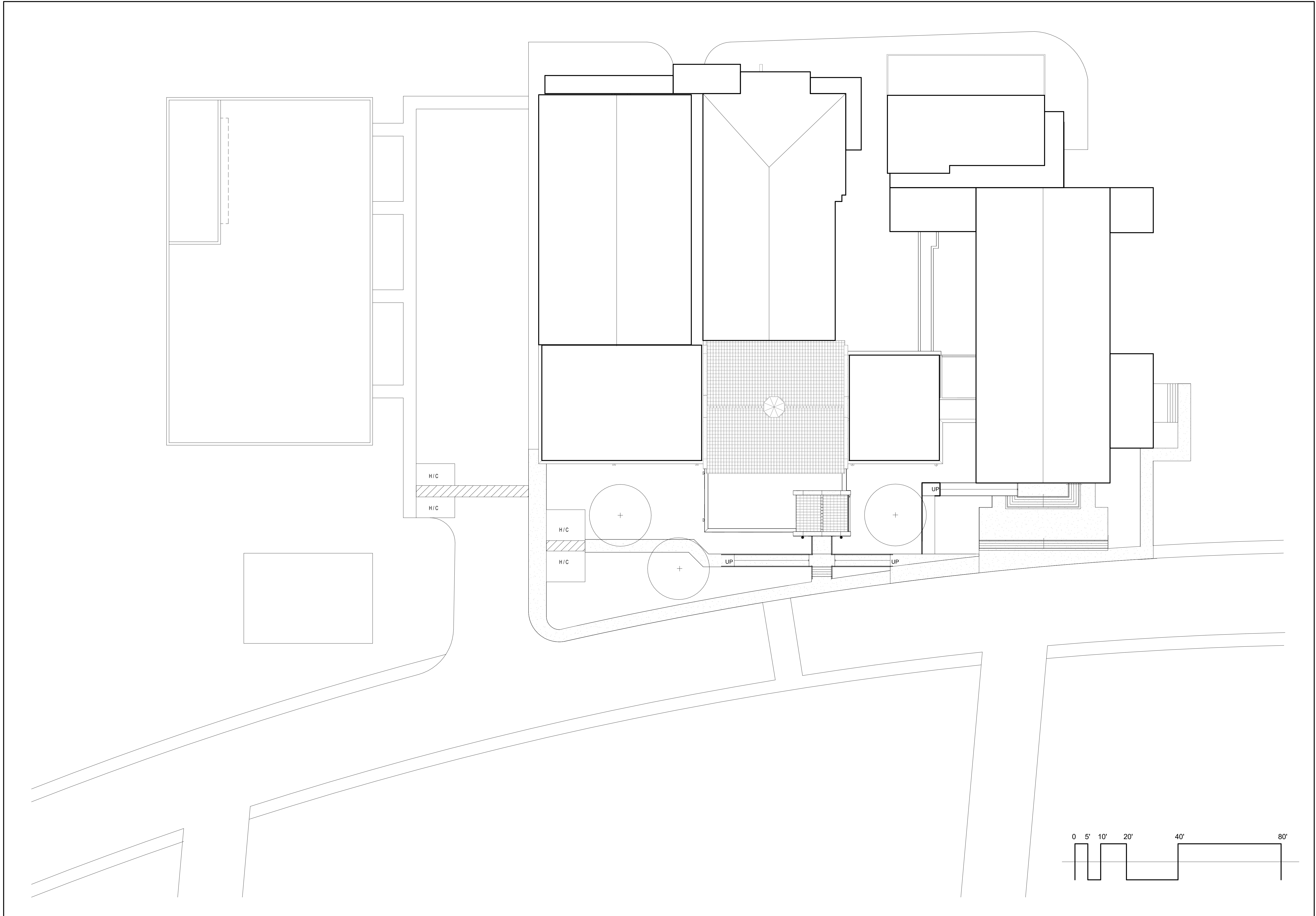

PROJECT LOCATION MAP





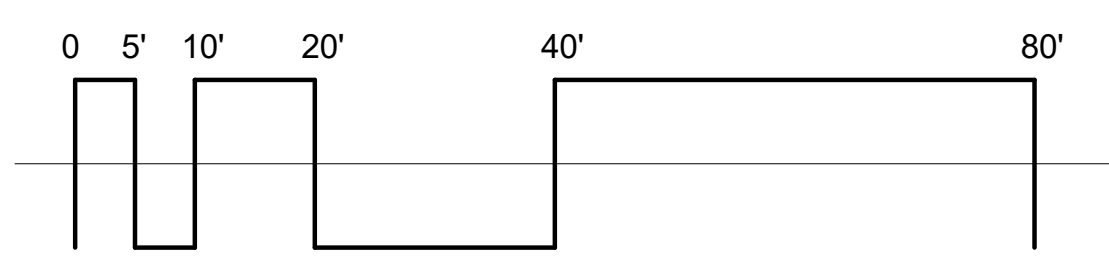
