

RESOLUTION NO. 2026 - 28

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF LEVY COUNTY, FLORIDA, ADOPTING A SCHEDULE OF FEES FOR SERVICES PROVIDED BY THE LEVY COUNTY HEALTH DEPARTMENT; PROVIDING FOR REPEAL OF RESOLUTION 2012-60 AND OTHER FEE SCHEDULES; PROVIDING AN EFFECTIVE DATE.

WHEREAS, on September 18, 2012 the Board of County Commissioners of Levy County, Florida ("the Board") adopted Resolution 2012-60 establishing an amended schedule for fees charged by the Levy County Health Department for certain services; and

WHEREAS, at the request of the Levy County Health Department, the Board now desires to amend such Health Department's fee schedule;
