

**TASK ASSIGNMENT 2023-6**

**ISSUED UNDER AN AGREEMENT FOR CONTINUING PROFESSIONAL SERVICES**

THIS TASK ASSIGNMENT is issued by LEVY COUNTY, a political subdivision of the State of Florida (the "County") to KIMLEY-HORN AND ASSOCIATES, INC., (the "Consultant"), pursuant to the Agreement between Levy County and Kimley-Horn and Associates, Inc., for Continuing Professional Services dated December 8, 2020 (the "Continuing Professional Services Agreement.") This Task Assignment is for the Wastewater Treatment Plan and Onsite Sewage Treatment and Disposal Systems (OSTDS) remediation plan within the Basin Management Action Plan (BMAP).

1. Scope of Services. Consultant shall provide all of the services and materials described in (the "Scope of Services") described in the Consultant's proposal dated November 3, 2023 titled Wastewater Treatment Plan and OSTDS Remediation Plan (the "Proposal"), which is attached as Exhibit "A" (consisting of three pages.)

2. Compensation. County shall compensate Consultant for its performance of the Scope of Services a not to exceed amount of Twenty Five Thousand Eight Hundred Dollars (\$25,800) as set forth in the Proposal. Invoices or requests for payments to Consultant shall be made in accordance with the Florida Local Government Prompt Payment Act, section 218.70 through 218.79, Fla. Stat.

3. In the event of a conflict between the documents attached or incorporated by reference to this Task Assignment, the documents will be given precedence in the following order

First: This Task Assignment;

Second: The Proposal attached as Exhibit "A"; and

Third: The Continuing Professional Services Agreement.

All other terms of the Continuing Professional Services Agreement not in conflict with this Task Assignment shall apply to Consultant's services to be provided under this Task Assignment and County's obligations under this Task Assignment.
