to conduct a full review of all operations and are currently doing a remote review of records. Mrs. Harper requested the Board consider waiving adoption fees until November 30th.

Comm. John Meeks stated he would be in favor of waiving the pet adoption fees until the end of the year. The Commissioners then agreed by consensus to approve waiver of adoption fees until the end of the year.

Requesting the Board's review of Legislative Ordinance No. 2024-4 approval regarding Revisions to Lot Splits: AN ORDINANCE OF LEVY COUNTY, FLORIDA, AMENDING CHAPTER 50 (LAND DEVELOPMENT CODE) OF THE COUNTY CODE OF ORDINANCES RELATED TO THE DIVISION OF LAND; BY REVISING SEC. 50-600 TITLED "GENERAL REQUIREMENTS" FOR LOT SPLITS; PROVIDING FOR INCLUSION IN THE CODE; PROVIDING SEVERABILITY CLAUSE; PROVIDING A REPEALING CLAUSE; PROVIDING DIRECTIONS TO THE CLERK AND AN EFFECTIVE DATE.
