Executive Summary

Background

County Manager Mary-Ellen Harper reported to the Board of County Commissioners during the October 22, 2024, Commission Meeting that she had put Animal Services Manager Rod Hastings on administrative leave on October 17, 2024, receiving a series of complaints. She further reported that she appointed Parks and Recreation / Mosquito Control Director Matt Weldon as the Interim Animal Services Director. She invited the University of Florida Shelter Medicine Program to review Levy County's Animal Services Operations thoroughly. County Manager Harper subsequently appointed Brandy Cannon as the Interim Animal Services Manager.

Cameron Moore from the University of Florida reviewed the Levy County Animal Services operations on October 24 and 25, 2024, as part of the Maddie's Million Pet Challenge Program. Maddie's Million Pet Challenge is a partnership between the University of Florida and the University

of California at Davis' Shelter Medicine Programs, Team Shelter USA, and the Open Door Veterinary Collective. Maddie's Million Pet Challenge Program awarded Levy County Animal Services a pro bono consult in response to my request for assistance. Research was completed before the onsite visit, including a review of the Florida State Statute, local ordinances, historical statistical trends, record keeping, website and social media, and discussions with partner agencies. During the onsite visit, the consultant toured the Animal Services property and met with individual staff members and the leadership team to learn more about the processes in place for both kennel operations and field services from the point of intake to outcome.

County Manager Harper received the Maddie's Million Pet Challenge Report on October 28, 2024. The report contained a multitude of recommendations that could not all be implemented simultaneously. The Board of County Commissioners approved County Manager Harper's recommendation to schedule a Strategic Planning Workshop on Tuesday, November 19, 2024, at 1 pm to consider, prioritize, and implement the goals and objectives recommended in this report.



Goals

Stakeholders established the following Goals for Animal Services for the 2025 planning period:

- Goal 1.1 Create a more robust Levy County Animal Services social media and website presence.
- Goal 1.2 Increase Animal and Animal Services Staff In-Person Community Interactions.
- **Goal 1.3** Develop a Levy County Animal Services Community Resource Program.
- Goal 2.1 Establish Levy County Animal Services Volunteer Program.
- **Goal 2.2** Develop a Levy County Animal Services Volunteer Recruitment Program.
- Goal 2.3 Develop a Levy County Animal Services Volunteer Training Program.
- Goal 3.1 Determine the cost of renovating the kennels and administrative offices.
- Goal 3.2 Determine the cost of building new kennels and administrative offices.
- Goal 3.3 Solicit public input on renovating or building new kennels and administrative offices.
- Goal 4.1 Provide a safe environment for the public, dogs, and cats in Levy County by enforcing state and local laws.
- Goal 5.1 Create a system of current systems, policies, and procedures to guide the operations of Animal Services.
- Goal 6.1 Create a current system, policies, and procedures to guide the clinical operations within Animal Services.

Next Steps

This Animal Services Strategic Plan provides a detailed roadmap for Levy County Animal Services based on the community's priorities, the Board of County Commissioners, and the Levy County Staff Members. Ideally, the Board of County Commissioners will adopt the Levy County Animal Services Strategic Plan or some variation of the plan. The approved document should be shared with all community members and regularly updated as goals and objectives are completed or modified.



The Strategic Planning Process

Held on November 19, 2024, the Levy County Animal Services Strategic Planning Workshop was a historical event. The Board of County Commissioners invited stakeholders from throughout the community to come together and participate in the Strategic Planning Workshop. Never before had Levy County initiated such an inclusive and transparent planning process for Animal Services.

An organization that knows where it is going, knows the environment in which it must operate, and identifies how to get there, has the best chance of meeting the needs of its community and achieving its vision.







Community members stepped forward and helped the Board of County Commissioners prioritize its strategic initiatives, goals, and objectives. It is now time for the Board of County Commission and the Management Team to roll up their sleeves and get to work. Collaboration, communication, and commitment are the keys to successfully achieving the short-range objectives, while the Board of County Commissioners works toward accomplishing the longer-range goals outlined in this Animal Services Strategic Plan.

To the extent possible, the Animal Services Budget should align with the elements of this Animal Services Strategic Plan. The Board of County Commissioners must also plan to allocate funding for the Animal Services Strategic Plan elements to keep funding from being the roadblock to successful implementation. The Animal Services Strategic Plan should be a "living" document, continuously updated to reflect the changing needs of the Levy County. Goals and objectives can and should change over time. The effective management of the Animal Services Strategic Plan will communicate the changes and the reasons for the changes in a timely fashion.







Definition of Terms

There are four main components to this Animal Services Strategic Plan: initiatives, goals, objectives, and outcomes. For purposes of this Animal Services Strategic Plan, they are defined as follows:

Initiative: The largest overarching element of the Animal Services Strategic Plan, an initiative is a broad enterprise where there may be multiple areas of focus.

Goal: A smaller component of and subordinate to an initiative, a goal focuses on one area but is still general in nature. Strategic planners consider initiatives accomplished upon completion of all goals under each initiative.

Objective: A smaller component of and subordinate to a goal, an objective is specific, measurable, action-oriented, realistic, and time-sensitive. Strategic planners consider goals accomplished with the completion of each corresponding objective.




Outcome: The description of the desired result of a goal or objective once accomplished.

Strategic initiatives, goals, objectives, and outcomes are essential to Animal Services' future work efforts. By following these components carefully, Animal Services will accomplish its objectives and, in turn, its goals and should benefit from reduced obstacles and distractions.

Role of the Animal Services Strategic Plan Manager

The County Manager will be responsible for managing the Animal Services Strategic Plan. The Strategic Plan Manager is responsible for tracking the progress made on each of the stated objectives in the Animal Services Strategic Plan. A Progress Reporting Template has been included at the end of this report to illustrate the format for tracking the progress of the objectives developed as part of this plan.





Role of the Board of County Commissioners and Management Team

Every Board of County Commissioners and Management Team member is responsible for understanding the Animal Services Strategic Plan, internalizing its goals and objectives, and helping the organization succeed. By being aware of the various efforts undertaken to achieve success, the Board of County Commissioners and Management Team can look for opportunities to assist in achieving its objectives.

While there should be room for unforeseen circumstances that require timeline adjustments or unexpected opportunities that may necessitate a




shift in a specific approach, these corrections should not be a common excuse for not achieving what was committed to at the inception of this Animal Services Strategic Plan.





Communication Strategies







No single method of communication reaches the four corners of any organization, so it is critical to use multiple methods of communication to keep the plan in the front of everyone's mind. Communication Strategies may include but should not be limited to:

- Progress updates from the Animal Services Officer, both verbally and in writing.
- Periodic Management Team meetings to review the Animal Services Strategic Plan.
 - Upload the Animal Services Strategic Plan electronically to make it accessible to the community.
 - Communicate status updates quarterly, celebrating successes and identifying struggles transparently.
 - Convene an annual meeting of internal stakeholders annually to update the plan and ensure accountability.

These strategies and mechanisms have advantages and disadvantages, but the primary theme is to use what works and communicate regularly and transparently within the Board of County Commissioners. By keeping the Animal Services Strategic Plan front and center, the plan will remain alive in the minds and hearts of everyone. Celebrating successes as they occur will increase the level of anticipation by the stakeholders for accomplishments in the other elements.







Development of Strategic Initiatives

Development of Strategic Initiatives

Following a review of Maddie's Million Pet Challenge Operational Consult for Levy County, six Strategic Initiatives were established for the Animal Services Strategic Plan.

To respect the time of the Strategic Planning Workshop Participants, the County Manager focused the Workshop on three strategic initiatives: Public Relations and Marketing, the Volunteer Program, and Facilities. The County Manager worked with Levy County Staff to address the Animal Control Code Enforcement, Administrative, and Clinical recommendations made in the Operational Consult separately. All six strategic initiatives, as well as their associated goals and objectives, are included in this Strategic Plan.





Mission, Vision, and Organizational Values

Mission

A Mission Statement explains the organization's reason for existence. It supports the vision and communicates purpose and direction to employees, customers, and other stakeholders. The mission statement should answer the questions, "What is our organization's purpose?" and "Why does our organization exist?"

The current Levy County Animal Services Mission Statement is: The Levy County Animal Services is an animal shelter that takes in unwanted or stray pets.

Members of the Strategic Planning Team, through open discussion and consensus, recommended the following updated Mission Statement for Levy County Animal Services:

Through collaboration with community partners, Levy County Animal Services will ensure a safe environment for the public, dogs, and cats in Levy County through education, enforcement of state and local laws, providing temporary care, and uniting animals with loving homes.

Levy County Staff reviewed this recommendation and offered the following update for ease of reading:

Levy County Animal Services will collaborate with community partners to provide a safe environment for the public, dogs, and cats in Levy County through education, enforcement of state and local laws, providing temporary care, and uniting animals with loving homes.





Vision

A Vision Statement establishes the ideal image that the organization wishes to achieve. It should answer the questions, "Where are we headed?" and "If we achieved all strategic goals, what would we look like ten years from now?"

Levy County Animal Services does not currently have a Vision Statement. Members of the Strategic Planning Team, through open discussion and consensus, recommended the following Vision Statement for Levy County Animal Services:

Promoting an environment of responsible pet ownership through progressive animal welfare initiatives, community outreach, and humane education.

Organizational Values

An Organizational Values Statement includes the core principles that guide the organization and its culture. In a values-led organization, the values guide decision-making and establish a standard to gauge and assess all actions.

The Organizational Values Statement should answer the questions "What values should guide the operations of our organization?" and "What conduct should our members uphold?" Establishing values embraced by all members of an organization is extremely important. Values define those features and considerations that make up the personality of the organization.







Levy County Animal Services does not currently have Organizational Values. Members of the Strategic Planning Team, through open discussion and consensus, recommended the following Organizational Values for Levy County Animal Services:

- **Compassion**: We shall have understanding and concern for people and animals without judgment.
- **Transparency:** We shall provide accurate information regularly.
- **Professionalism**: We shall treat people and animals with respect at all times.
- **Responsibility:** We shall keep people accountable for the humane treatment of their animals.
