COUNTY COORDINATOR

B. Seeking Board direction on the letter received from the Town of Bronson dated March 2, 2021 regarding the possible purchase of the old high school gym and leasing of the football field.

PROCUREMENT

A. Requesting Board approval of the Amendment to the Medical Examiner Transport Services Agreement between Levy County and Knauff Funeral Homes, LLC.

Comm. Rock Meeks made a motion to approve the Amendment to the Medical Examiner Transport Services Agreement with Knauff Funeral Homes, LLC as requested. Second was made by Comm. Rooks and the MOTION CARRIES.

B. Requesting Board approval to waive the bid process and accept the proposal submitted by iWorQ Systems, Inc. for the Development Department upon review of the agreement by the County Attorney. The onetime set-up fee for this program is \$27,000 and the annual subscription fee will be \$16,000.

Comm. Rock Meeks made a motion to approve waiving the bid process and accept the proposal submitted by iWorQ Systems, Inc. as requested. Second was made by Comm. Rooks and the MOTION CARRIES.

C. Requesting Board approval of Resolution 2021-028 certifying the County's qualification to submit an application and receive funds related to the Florida Fish and Wildlife Conservation Commissions' Florida Boating Improvement Program; authorizing the Chair to execute a Grant Agreement and any Amendments, if awarded; authorizing Wilbur Dean, County Coordinator, to act as Project Manager, execute other documents and perform administrative actions.

Comm. Rooks made a motion to approve Resolution 2021-028 as requested. Second was made by Comm. Rock Meeks and the MOTION CARRIES.

DEPARTMENT OF PUBLIC SAFETY

Mitch Harrell, Director

A. Requesting Board approval of the included Budget Amendment in the amount of \$183,000 to appropriate Contingency Reserves for the Paramedic and EMT incentives approved in December.

Comm. Brooks made a motion to approve the Budget Amendment as requested. Second was made by Comm. Rock Meeks and the MOTION CARRIES.

B. Requesting Board approval and Chairman's signature of the Certification Statement for the Use of Certified Public Funds as well as the Board's approval of Resolution 2021-031 accepting the funds and increase the budget. Levy County is receiving \$39,591 and \$18,494.39 is the State Share amount the AHCA is claiming to the Federal Government to draw down the \$35 million of Federal Share.

Comm. Joyner made a motion to approve the Chairman's signature on the Certification Statement for the Use of Certified Public Funds and approval of Resolution 2021-031 as requested. Second was made by Comm. Rock Meeks and the MOTION CARRIES.

COUNTY ATTORNEY

Atty. Anne Bast Brown requested Board approval of the Amendment to Agreement for Legal Services provided by Allen, Norton & Blue, P.A. for legal services related to employment issues. The billing rate for partners, senior associates and associates will be \$285 per hour, an increase of \$25 per hour. The billing rate for paralegals will be \$110 per hour, an increase of \$10 per hour.

Comm. Rooks made a motion to approve the Amendment to Agreement for Legal Services provided by Allen, Norton & Blue, P.A. as requested. Second was made by Comm. Rock Meeks and the MOTION CARRIES. Comm. Brooks voted NO.

Audience member Linda Cooper urged the Board to consider requesting proposals for these services.

PUBLIC COMMENTS

Dana Sheffield inquired if the Board had an opinion on the State's push to make School Board members non-paid positions.

Comm. John Meeks responded he did not agree with this idea personally.

Mr. Sheffield invited everyone to the Expo scheduled for April 24th at the Cross City Airport.

Mayor Merritt stated it had been a pleasure to work with the Commissioners and staff during her years as Mayor of Yankeetown.

COMMISSIONERS' REPORTS

Comm. Joyner encouraged everyone to attend the Suwannee River Livestock Fair and Sale this week. He stated the sale day is tomorrow.

Comm. Rooks reported of her continuing efforts to prevent the toll road from coming through Levy County.

Comm. Brooks congratulated the Williston FFA Livestock Judging team for bringing home a State Championship.

Comm. Brooks brought dates to the Board for a Solar Workshop: April 12th or April 19th at 6:00 P.M. The Board agreed by consensus to schedule a Solar Workshop for April 12th at 6:00 P.M.

Comm. John Meeks stated the Grand Champion Swine was awarded last night to a student with the Bronson Middle FFA.

Comm. John Meeks reported the State Legislature is in session at this time.
