**A RESOLUTION OF THE BOARD OF COUNTY
COMMISSIONERS OF LEVY COUNTY, FLORIDA, TO
ADVERTISE THE HEARING FOR THE VACATION,
ABANDONMENT, AND CLOSURE OF A PORTION OF N. W.
147TH PLACE, LOCATED IN LEVY COUNTY, FLORIDA.**

WHEREAS, the Board of County Commissioners of Levy County, Florida ("the Board"), desires to consider the vacation of a portion of a public road in Levy County, Florida; and

WHEREAS, the roadway sought to be vacated, abandoned and closed is described as follows: that portion of NW 147th Place, a/k/a south line of the NW ¼ of the NW ¼ of Section 10, Township 11 South, Range 14 East, from the west boundary line of Lot 5, Block 2, Jeanne Heiber Subdivision, according to the plat thereof recorded at Plat Book 4, Page 21, of the public records of Levy County, Florida, eastward to the east boundary line of said Lot 5.

WHEREAS, it has been represented to the Board that the closing and abandoning of the above-described roadway will not adversely affect the ownership or right of convenient access of any property owner in the immediate area.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Levy County, Florida that a public hearing on the proposed closing of the above-described roadway in Levy County, Florida, be scheduled for Tuesday, July 20, 2021, at 9:00 A.M., or as soon thereafter as it may be heard, and that proper legal notice of said hearing be published according to the laws of the State of Florida.



NOTICE OF INTENT TO CONSIDER VACATING PUBLIC ROAD

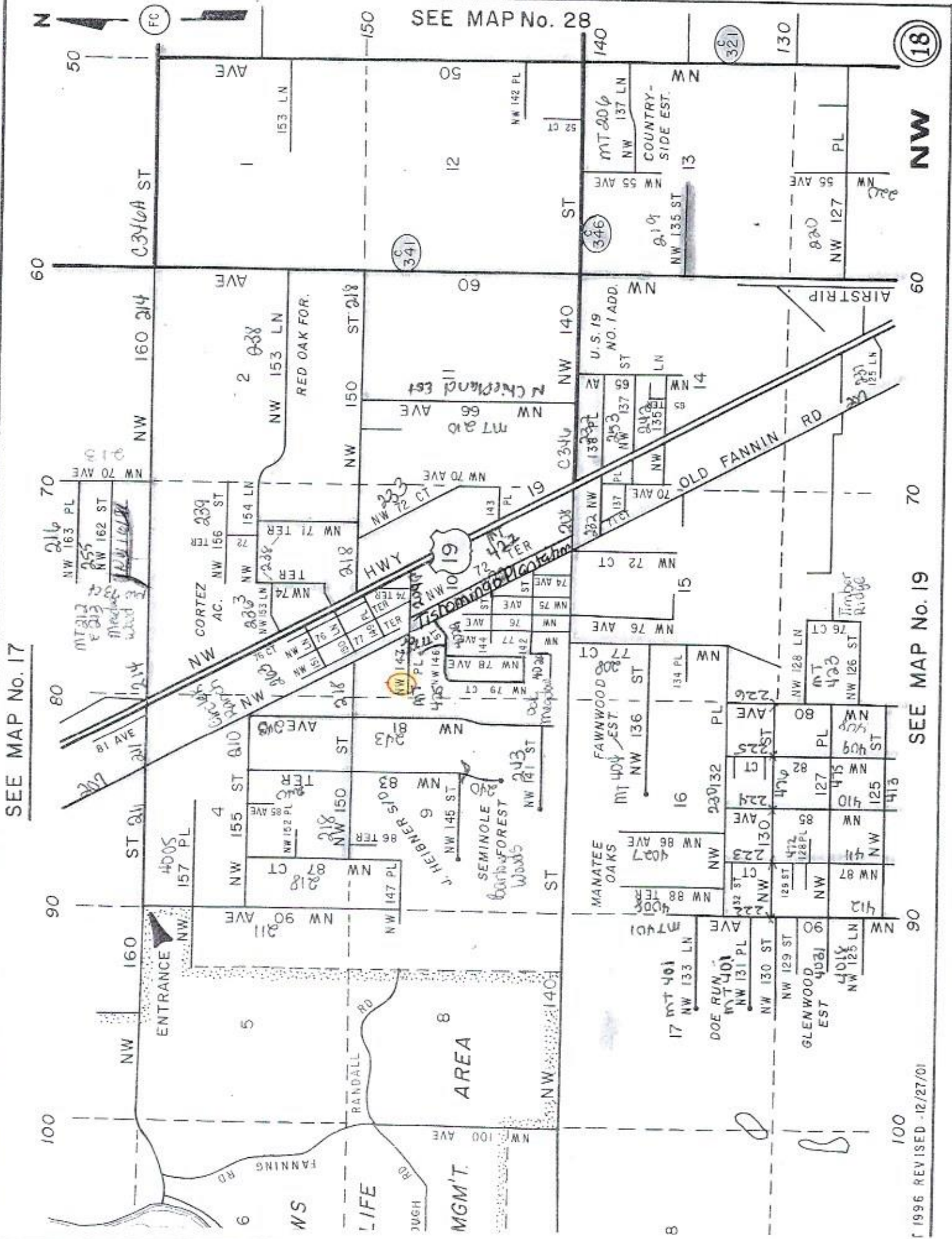
