TASK ASSIGNMENT 2024-7

ISSUED UNDER AN AGREEMENT FOR CONTINUING PROFESSIONAL SERVICES

THIS TASK ASSIGNMENT is issued by LEVY COUNTY, a political subdivision of the State of Florida (the "County") to BARNETT FRONCZAK BARLOWE & SHULER ARCHITECTS (BFBSA), (the "Consultant"), pursuant to the Agreement between Levy County and BFBSA, for Continuing Professional Services dated December 8, 2020 (the "Continuing Professional Services Agreement.") This Task Assignment is for the Levy County Auditorium Acoustical Renovation.

- 1. <u>Scope of Services.</u> Consultant shall provide all of the services and materials (the "Scope of Services") described in Consultant's proposal dated May 7, 2024 titled Levy County Auditorium Acoustical Renovation (the "Proposal"), which is attached as Exhibit "A" (consisting of nine pages.) The purpose of this Scope of Services is to design improvements to the acoustic environment within the Auditorium so that it better functions as a public meeting space, with improvements that address sound isolation and intrusive noise, reduce background noise levels and control reverberant sound energy.
- 2. <u>Compensation.</u> County shall compensate Consultant for its performance of the Scope of Services a not to exceed amount of Thirty Five Thousand Eight Hundred Ninety Six (\$35,896.00) as set forth in the Proposal. Invoices or requests for payments to Consultant shall be made in accordance with the Florida Local Government Prompt Payment Act, sections 218.70 through 218.79, Fla. Stat.
- 3. In the event of a conflict between the documents attached or incorporated by reference to this Task Assignment, the documents will be given precedence in the following order

First: This Task Assignment

Second: The Proposal attached as Exhibit "A"; and

Third: The Continuing Professional Services Agreement.

All other terms of the Continuing Professional Services Agreement not in conflict with this Task Assignment shall apply to Consultant's services to be provided under this Task Assignment and County's obligations under this Task Assignment.
