PROJECT UNDERSTANDING

This agreement defines the terms under which ME, LLC shall provide professional services to CLIENT for design and permitting, bidding services, and construction administration throughout the project. The scope of the project consists of permitting and replacing twelve (12) Daytime Navigational Channel Markers within the Waccasassa Bay.

- Attend meetings as required with the contractor, County staff, and other interested parties;
- Make up to three (3) site visits during construction to observe contractor's installation;
