Good afternoon,

I'd be happy to assist with the questions that you presented in the email below regarding the Town of Inglis's CPTA Grant.

During conversations with the Town and their consultant, a concern was verbally presented to DEO that the Town may not be in a position to successfully administer a grant that operates on a cost reimbursement basis. Subsequently, the Town asked if it could be possible to transfer the grant to Levy County. We have not received an official request for a transfer in writing from the Town. However, email communications from the consultant noted the Town was interested in assessing if this is an option.

The possibility of transferring the Grant Agreement, and what would be needed from each local government to facilitate that transfer, is something that is still being considered by DEO leadership. If Levy County determines that it is interested in this transfer, then I know we would like to receive the name and contact information for the County staff member who would act as the grant manager. That way we can continue further coordination with you all through that contact. I will be happy to advise as soon as I hear any further direction on this matter from DEO leadership. Thank you.
