**AN ORDINANCE OF LEVY COUNTY, FLORIDA, AMENDING THE ZONING MAP ATLAS BY REZONING CERTAIN REAL PROPERTY CONSISTING OF APPROXIMATELY 11.6 ACRES (PARCEL ID 0433100100) GENERALLY LOCATED ON NE HWY 27 ALT, WILLISTON, FLORIDA FROM SINGLE-FAMILY RESIDENTIAL, URBAN (R-2) AND NEIGHBORHOOD COMMERCIAL (C-2) TO MODERATELY INTENSIVE COMMERCIAL (C-3); PROVIDING DIRECTIONS TO THE COUNTY COORDINATOR; PROVIDING A SEVERABILITY CLAUSE; PROVIDING A REPEALING CLAUSE; PROVIDING FOR EXCLUSION FROM CODIFICATION; PROVIDING DIRECTIONS TO THE CLERK AND PROVIDING AN EFFECTIVE DATE.**
