

RESOLUTION NUMBER 2026-21

**A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS
OF LEVY COUNTY, FLORIDA, AMENDING THE FINAL BUDGET
FOR FISCAL YEAR 2025-2026 IN THE AMOUNT OF \$82,985 DUE TO
RECEIPT OF ADDITIONAL REVENUE FROM A STATE AID TO
LIBRARIES GRANT; AND PROVIDING AN EFFECTIVE DATE.**

WHEREAS, the Board of County Commissioners of Levy County, Florida, on September 23, 2025, held a public hearing as required by Section 200.065, Florida Statutes, and adopted Resolution 2025-62 Approving the Final Budget for Fiscal Year 2025-2026 (the “FY25-26 Budget”); and

WHEREAS, pursuant to Section 129.06(2), Florida Statutes, it is necessary to amend the FY25-26 Budget to recognize and appropriate grant revenues received for their intended purposes.

NOW, THEREFORE, BE IT RESOLVED, by the Board of County Commissioners of Levy County, Florida, that:

1. The above findings are true and correct and are hereby incorporated herein by reference.
2. The FY 25-26 Budget hereby amended and increased by \$82,985 as set forth in the summary set forth on Exhibit A, which is attached hereto and incorporated herein by reference.
3. All resolutions or parts of resolutions in conflict with any of the provisions of this resolution are hereby repealed to the extent of the conflict.
4. If any provision of this resolution or the application thereof to any person or circumstance is held invalid, it is the intent of the Board of County Commissioners that such invalidity shall not affect other provisions or applications of the resolution which can be given effect without the invalid provision or application and, to this end, the provisions of this resolution are declared severable.
5. This Resolution shall take effect immediately upon its adoption.
