C. Requesting Board direction of a grader repair. The Road Department has a 2000 John Deere grader with 115,227 hours in need of a transmission replacement for the quoted price of \$45,423.38. This will be the 2nd transmission since 2019 at 12,236 hours. A comparative pricing is included for the Board for a new/used grader of different makes and models for information purposes.
