The ordinance implementing the amendment to the Levy County Comprehensive Plan was approved for transmittal by the Levy County Planning Commission at their August 2, 2021 meeting voting 3-0 recommending approval to the BOCC. The Levy County Board of County Commissioners on August 17, 2021 at a public hearing voted 4-0 to approve transmittal of proposed **Petition No. LSTA 21-02** along with **Ordinance 2021-0013**. There are no findings of the local governing body that were not included in the ordinance that provided the basis of the transmittal or determination not to transmit the proposed Element.
