**A RESOLUTION OF THE BOARD OF COUNTY
COMMISSIONERS OF LEVY COUNTY, FLORIDA,
AMENDING THE FINAL BUDGET FOR FISCAL YEAR
2021-2022; PROVIDING FOR AN EFFECTIVE DATE**

WHEREAS, the Board of County Commissioners of Levy County, Florida, (“the Board”) on September 21, 2021 held a public hearing as required by Section 200.065, Florida Statutes, and adopted Resolution 2021-108, adopting the Final Budget for Fiscal Year 2021-2022; and

WHEREAS, an amendment to the 2021-2022 Final Budget is required as a result of an appropriation of funds from the reserve for future construction and improvements for the purpose for which the reserve was made; and

WHEREAS, on October 19, 2021, the Board considered this Resolution pursuant to the provisions of Section 129.06(2)(d), Florida Statutes, in order to amend the Fiscal Year 2021-2022 Final Budget to reflect the changes required; and

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Levy County, Florida, that:

1. The Fiscal Year 2021-2022 Final Budget adopted by Resolution 2021-108, is hereby amended as follows:

The appropriations for expenditures in Article V Grant Fund shall be increased by \$200,000.00, as reflected in the attached budget amendment form.

2. This resolution shall take effect immediately upon its adoption.
