Diane Garte stated she was not against composting businesses, but was in favor of size restrictions for the property used.

Maria Wise spoke on behalf of the Levy County Horse Industry Council of concerns, but was not against the composting industry in Levy County.

Kanesha Carnegie stated she was not against composting businesses, but would like to see them located away from residential areas.

Kim Wheeler encouraged the Commissioners to postpone any decisions until more information is obtained, referring to the current updating of requirements and standards by the Department of Environmental Protection.

Planning Commission member, Tom Harper spoke of the agriculture exemption status of property when sold.

Sallie Ann Collins spoke of a Resolution approved by the Board over a year ago concerning Land Use, stating copies were to be forwarded to the FDEP, Department of Agriculture, and the Water Management District. She inquired if there was any response from these departments.

Ms. Hectus responded staff had received no response from any of these departments.

Following discussion, the Commissioners agreed to research further before giving Atty. Shalley direction for drafting of a Resolution.
