TASK ASSIGNMENT 2025-1 ISSUED UNDER AN AGREEMENT FOR CONTINUING PROFESSIONAL SERVICES

- 2. <u>Compensation.</u> County shall compensate Consultant for its performance of the Scope of Services as set forth in the Proposal. Invoices or requests for payments to Consultant shall be made in accordance with the Florida Local Government Prompt Payment Act, sections 218.70 through 218.79, Fla. Stat.
- 3. In the event of a conflict between the documents attached or incorporated by reference to this Task Assignment, the documents will be given precedence in the following order:

First: Task Assignment 2025-1; and

Second: The Continuing Professional Services Agreement.

All other terms of the Continuing Professional Services Agreement not in conflict with this Task Assignment shall apply to Consultant's services to be provided.

Timeline of Review and Return for Submitted Plans

Upon receipt of the site plan submittal from Levy County staff, a JBPro Staff Engineer will perform a review of the entire project within 7 business days. After the initial review, a JBPro Project Manager meets with the Staff Engineer to discuss the review comments. Any additional comments and design suggestions are compiled within 10 business days and a complete review is returned to the County within 14 working days. For simple projects the reviews can be accomplished even sooner, and subsequent re-submittal reviews are often handled within a week or less.
