(52:09) Audience members Ada Marie Keaton, Reggie Stacey, Curtis Stacey, Jaime Griffin, Clayton Lott, and Elijah Williams spoke regarding the old gym and urged the Commissioners to consider other options.

COMMISSIONERS' REPORTS

(1:11:02) Comm. Meeks spoke of an item mentioned by the Governor to abolish property taxes and inquired if anyone had any information as to what the plan was to compensate for this loss of revenue. Comm. Hiers stated he had been in contact with individuals indicating there was a plan to compensate for the amounts which would be lost to the county if this happens. Comm. Meeks then spoke of a purchase by the State of Florida of 19,000 acres in Levy County and expressed his concern with this.

(1:23:27) Comm. Kennedy spoke of an upcoming Court Facilities meeting where some projects will be discussed concerning the Courthouse. He then reminded everyone of the Suwannee River Livestock Show and Fair taking place soon and encouraged everyone to support the youth of Levy and surrounding counties.

(1:24:52) Comm. Hiers also encouraged everyone to support the youth with projects at the upcoming Fair. He also spoke of a parade and celebration held to honor former Williston resident, Quinyon Mitchell, who now plays football for the Philadelphia Eagles.

Mills also reported of the recently held North Central Regional Planning Council meeting she attended and of her recent assignment to the Withlacoochee Task Force.
