In October 2023, the Road Department received a Petition (#2024-001) from an abutting property owner to vacate portions of undeveloped right of way within Cedar Key Heights. County Staff reviewed the Petition and found it appropriate to vacate this undeveloped right-of-way. Mailed notice was provided to surrounding property owners and utility companies (if any). This initial resolution, Resolution 2024-38, was adopted August 20, 2024 setting a public hearing for October 8, 2024 at 9:00 to consider a final resolution to vacate the right-of-way. Notice of the public hearing was published on September 26, 2024 in the Levy Citizen. If the Board adopts the final resolution to vacate the right-ofway at this public hearing, County Staff will publish notice of the vacate within 30 days.
