NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Levy County, Florida, that:

1. The Fiscal Year 2019-2020 Final Budget adopted by Resolution 2019-078, is hereby amended as follows:

The CARES Act Relief Budget shall be increased by \$1,937,606.00, as reflected in the attached budget amendment form.

2. This resolution shall take effect immediately upon its adoption.
